The Oklahoma Film and Music Office (OFMO) has completed all statutory requirements set out in 68 OS 3624( C ) which states that the rebate program is to be administered by the Office of the Oklahoma Film and Music Commission and the Oklahoma Tax Commission. The OFMO has complied with the requirements of 68 OS 3624 ( D ) and in accordance with 68 OS 3624 (F), has approved the claim for "The Killer Inside Me".

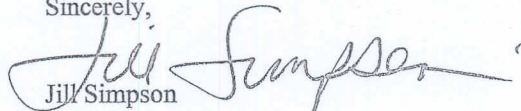
Pursuant to the above statute, the total rebate payment is \$440,776.20 for this approved claim from funds in the Oklahoma Film Enhancement Rebate Program Revolving Fund created in Section 3625 of this title. Provided, no claims for rebate for expenditures made on or after July 1, 2009, shall be paid prior to July 1, 2010. Thusly, the payment shall be divided into two separate payments. The first payment, which is payable upon receipt of this letter, for Oklahoma expenditures on or before June 30, 2009 is \$408,984.30 The second payment, which is payable after July 1, 2010, for Oklahoma expenditures on or after July 1, 2010 is \$31,791.90

As specified in the Assignment Memorandum provided to OFMO by Killer Inside Me Productions, LLC on June 29, 2009, the final rebate payout is payable to:
