INDICTMENT

FOR:

SEXUAL BATTERY in violation of Title 21 O.S. § 1123 (B) [Count 1]

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Twelfth Multicounty Grand Jury was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from March 31, 2009, until September 30, 2010, or until the designated presiding judge determines the Twelfth Multicounty Grand Jury has reached reasonable completion of its investigations, but in any event, no more than twenty-four (24) months from the commencement of its term. That the said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and woman, legally drawn and summons according to law and then and there examined, impeached, sworn and charged according to law to diligently inquire into and true presentment make of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath and in the name and by the authority of the State of Oklahoma, do present and find that:

COUNT 1:

Commencing on or about the 1st day of December, 2007 A.D., through the 31st day of December 2007, A.D., the crime of **SEXUAL BATTERY** was feloniously committed in Oklahoma County, Oklahoma, by **KEVIN E. ROWLAND**. During all times set forth herein, and within said County and State, **KEVIN E. ROWLAND** who acting knowingly and intentionally touched and felt the body and/or private parts of **M.H.** in a lewd and lascivious manner and in a manner calculated to arouse and excite sexual interests and without the consent **M.H.**, to-wit:

The defendant, **KEVIN E. ROWLAND**, touched the private parts of **M.H.** while making a sexually explicit statement in reference to **M.H.**'s private parts contrary to the provisions of section 1123 (B) of Title 21 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.
