ON 021209 AT APPROXIMATELY 0845, SGT. PAZ #912 AND I WERE TRAVELING WESTBOUND ON I-240. SGT. PAZ DIRECTED ME TO STOP A WHITE TRUCK (TAG #390XQO). THE VEHICLE WAS DRIVEN BY IP HARRISON.

WHEN I GOT BEHIND THE VEHICLE, I NOTICED A WHITE SIGN WITH BLACK LETTERS. THE WRITING SAID "ABORT OBAMA NOT THE UNBORN". THE SIGN WAS APPROXIMATELY 14" BY 10". I INITIATED A TRAFFIC STOP AT SW. 119TH AND I-44 SOUTHBOUND. WE MADE CONTACT WITH IP HARRISON. I ASKED HIM WHAT THE SIGN WAS FOR. IP HARRISON SAID THAT HE DOESN'T BELIEVE IN ABORTION BECAUSE HE IS A CHRISTIAN.

SGT. PAZ INFORMED IP HARRISON THAT THE U.S. SECRET SERVICE COULD CONSTRUE THIS AS A THREAT AGAINST PRESIDENT OBAMA. IP HARRISON TOLD US THAT IT WAS NOT A THREAT, BUT THAT "ABORT OBAMA" MEANS TO IMPEACH HIM. SGT. PAZ INFORMED IP HARRISON THAT WE WOULD HAVE TO TAKE THE SIGN AND BOOK IT INTO THE PROPERTY ROOM. I GAVE IP HARRISON THE CASE NUMBER AND WE INFORMED HIM THAT HE HAS A RIGHT TO HIS OWN BELIEFS, BUT HE HAS TO BE CAREFUL HOW HE EXPRESSES THEM.

BEFORE WE COULD BOOK IN THE SIGN, LT. PARKER #664 CONTACTED US. HE SAID IP HARRISON CALLED THE DEPARTMENT AND WE WERE TO RELEASE THE SIGN. LT. PARKER TOOK CUSTODY OF THE SIGN.
