Joint Resolution pensioning sundry persons of Maryland County.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1ST. That from and immediately after the passage of this Joint Resolution, C. C. Hoffman, S. F. Morell, Woa Sea and Jacob Baker, soldiers who were wounded in the War of 1896 be placed on the Pension list; each to receive Twenty five (\$25.00) dollars annually.

Sec. 2ND. And the Secretary of the Treasury, under Warrant of the President, is hereby authorized to draw for the

same, out of any money not otherwise appropriated.

Any law to the contrary notwithstanding. Approved December 23rd, 1902,

Joint Resolution incorporating The "Morning Star Household of Ruth" No. 1758 of Lower Buchanan in Grand Bassa, County.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1st. That Mary S. Ragland, P. M. N. G., Mary L. Whitfield, M. N. G., Florence A. Noel, R. N. G., Hannah B. Gabbidon, N. G., M. L. Logan, W. T. Anna M. Johnson, W. P., Daniel P. Mason, W. C. Alzada, L. Smith, W. C., and Martha L. Brumskine, W. C., and such others as may thereafter be connected with them, be and they are hereby declared a body politic and Corporate under the name and style of The "Morning Star Household of Ruth" No. 1758 of Lower Buchanan in the County of Grand Bassa; and shall be capable in law of enjoying all of the rights and privileges of such other Bodies Corporate.

Joint Resolution incorporating the Number one Brass Band Company of Brewerville.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1ST. That from and immediately after the passage of this Joint Resolution, the Number one Brass Band Company of Brewerville be and are hereby constituted and declared a body politic and corporate under the name and style of Number one "Brass Band Company of Brewerville," of the Republic of Liberia and shall be capable in law to receive, hold and enjoy real and personal estate to the amount of Two thousand dollars (\$2000.00) for the use and benefit of said Company, and shall have perpetual succession of officers and members, and as such may sueand be sued, plead and be impleaded before any Court of this Republic having competent jurisdiction.

Sec. 2ND. It is further resolved that the Number one Brass Band Company of Brewerville is permitted to do all other matters and things done by similar bodies Corporate.

Any law to contrary notwithstanding Approved December 23rd, 1902.

Joint Resolution incorporating the Harper City Lodge No. 5436 of Odd Fellows.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1ST. That James J. Dossen, P. N. F. W. H. Yancy, N. F., W. H. Cummings, P. N. G., Anthony D. Wilson, N. G., Levi E. Boyer, V. G., John H. Tubman, W. T., John H. Nelson, W. A., John M. McIntosh, W. C., James D. Hardy, P. S., Mansfield F. Yancy, E. S. Williams, G. McKnight, R. S. N. G., Henry J. R. Cooper, L. S. V. G., Nathan Barnes, R. S. V. G., Grandolle A. Howard, Warden, Allen W. Yancy, Jr. Guardian, together with such other officers and members who now are or hereafter may become connected with said Lodge be constituted and declared a body Corporate, under the name and style of Harper City Lodge No. 5436 of the Grand United Order of Odd Fellows, United States of America with all the rights, and privileges and immunities appertaining and belonging to other Lodges of the Order with perpetual succession of Officers.

Sec. 2ND. That the said Lodge shall be capable in law to receive, hold and enjoy real and personal estate to the amount

of Five thousand dollars (\$5000.00) and to plead and be impleaded in any of the Courts of this Republic.

Any law to the contrary notwithstanding. Approved December 23rd, 1902.

Joint Resolution making an appropriation to build a suitable Court House in the County of Since.

Whereas the County of Sinoe is greatly in need of a Court House, as the one now in use is unfit, and unsafe to hold Sessions of the Court, and having no suitable building in which to conduct the Court.

Therefore it is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SE. IST. That from and immediately after the passage of this Joint Resolution, the sum of Six Thousand (\$6000.00) Dollars be, and the same is hereby appropriated to build a suitable Court House in the County of Sinoe. Dimension as follows, length 45 feet, width 30 feet and height 19 feet. The same is to be properly completed.

SEC. 2ND. It is further resolved that the Secretary of the Treasury be, and, he is hereby authorized to draw in favor of the undertaker who is to furnish all materials, and said drafts to be drawn on the Sub-Treasury of Sinoe County out of any monies not otherwise appropriated.

Any law to the contrary notwithstanding. Approved December 23rd, 1902.

Joint Resolution incorporating Reeves Institue in the Town of Fortsville in the County of Grand Bassa.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1ST. That C. B. Reeves and A. C. Reeves Trustees and Proprietors of the Institute known as Reeves Institute of the Town of Fortsville in the County of Grand Bassa, carrying on educational work for the public benefit and all others as may be here: fter connected with them, be and they are hereby cons ituted and declared a bedy politic and corporate under the name and style of "Reeves Institute" and shall be capable in law to receive and hold real and personal property to the amount of Thirty Thousand Dollars, for the use and benefit of said Institution; and shall have perpetual

succession of Officers and members, and as such may suc and be sued plead and be impleaded in any Courts of this Republic having competent Jurisdiction.

Sec. 2ND. It is further resolved that the said Institution be permitted to do all other matters and things done by similar

bodies corporate.

Any law to the contrary notwithstanding. Approved December 23rd, 1902.

An Act amendatory and supplementary to An Act fixing the duty on Piassava, Approved January 80th, 1900.

It is enacted by the Senate and House of Representatives of the Republic of Liberia, in Legislature assembled.

SEC. 1ST. That from and after the passage of this Act, the Act, above mentioned, is so altered and amended as to read—that the Export duty on Piassava shall be one half a cent per pound, one half of which shall be paid in gold or silver coin, the same to be used for the support of Liberia College and the feeders thereof, and the other half of said duty to be paid either in coin, currency or General Government and County Checks.

Joint Resolution appropriating an amount of money to build at Iron Bridge across the Hoffman tiver, in Harper, Maryland County.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1ST; That from and immediately after the passage of this Joint Resolution the sum of Two thousand dollars be, and the same is hereby appropriated for the purpose of building an Iron bridge across the Hoffman River in the County of Maryland.

Sec. 2ND. And the Secretary of the Treasury, under warrant of the President, be and he is hereby authorized to draw for the same out of any money not otherwise appropriated

Any law to the contrary notwithstanding.

Approved December 31st 1902.

Joint Resolution aiding the Citizens of Lexington in Since County to build a bridge or Causeway between Lexington and Farmersville.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1. That from and immediately after the passage of this Joint Resolution the sum of Three thousand dollars is hereby appropriated for the purpose of assisting the Citizens of Lexington, in the County of Sinoe to build a bridge or causeway between Lexington and Farmersville in said County.

SEC. 2. And the Secretary of Treasury, under Warrant of the President, is hereby authorized to draw for the same

out of any money not otherwise appropriated.

Any law to the contrary notwithstanding Approved December 31, 1902.

Joint Resolution appropriating Two hundred (\$200.00) dollars per annum for the benefit of Reeves Institute of Grand Bassa County.

Whereas it should be incumbent on the Government to

aid and foster all Institutions of learning, and

Whereas the uncivilized population of Liberia should receive special attention from the Government in being civilized and Christianized with a good Education, theoretical and practical, for the future utilization in the Body politic, and

Whereas Reeves Institute, of Grand Bassa County, is endeavoring to carry into effect such a design on unbiased

principles, and

Whereas Hon. C. B. Reeves and A. C. Reeves have thus far principally, of their own responsibilities, and with a little aid from a few christian and philanthropic friends succeeded in founding a school that contains 92 boarding pupils, thirty (30) of whom are children from the heathen population of our Country,

Therefore it is resolved by the Senate and House of Representatives of the Republic of Liberia, in Legislature assembled.

That from and immediately after the passage of this Joint Resolution, the sum of Two hundred (\$200.00) dollars per annum is appropriated for the benefit of the Native Youths of Reeves Institute in Grand Bassa County; and the Secretary of the Treasury, be and he is hereby authorize p

under warrant of the President, to draw for the same out of any money from the Public Treasury not otherwise appropriated.

Any law to the contrary notwithstanding.

Joint Resolution granting to Henry O. Stewart of Montserrado County, at Mount Coffee Section, Forty acres of land for Mission and Industrial purposes.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1st. That from and after the passage of this Joint Resolution Forty acres of land is granted to Henry O.

Stewart of Montserrado County in Mount Coffee.

SEC. 2nd. It is further resolved that the Land Commissioner of Montserrado County is hereby authorized to order the Survey or to Survey for the said Henry O. Stewart Forty acres of land out of any portion of lands not otherwise appropriated. He the said Henry O. Stewart paying all the expenses.

SEC. 3rd. It is further resolved that he shall hold the said parcel of land so long as it is used for the legitimate

purpose for which it is given.

Sec. 4th. It is further resolved that if at any time after the grant of said land, any minerals should be discovered on any portion of it, the Government shall have the exclusive rights of disposal of said deposits.

Any law to the contrary notwithstanding

Joint Resolution removing E. Moulton, Judge of the District Court of Helf Cavalla in the County of Maryland Republic of Liberia.

Whereas E Moulton, Judge of the District Court of Half Cavalla. Maryland County has caused a great scandal upon the Judiciary of said District: And whereas he has been guilty of gross unbecoming conduct as a Judge, to us known from a petition from the Citizens of that District: And whereas the Legislature is not desirous of impeaching the said Judge, E. Moulton

Terefore it is resolved by the Senate and House of Rep-

resentatives of the Republic of Liberia in Legislature assembled.

Sec. 1st. It is resolved that from and immediately after the passage of this Joint Resolution the President is hereby authorized and directed to remove the said E. Moulton, Judge of the District Court of Half Cavalla in the County

of Maryland, and to appoint another in his stead.

Sec. 2nd. It is further resolved that this Joint Resolution passed by a two third vote constitute the Joint address for the removal of a Judge in accordance with the Con-

stitution of this Republic.

Any law to the contrary notwithstanding Passed by Limitation.

Joint Resolution to pension Richard Barrett of Montserrado County.

Whereas the petition of Richard Barrett shows that he was severely wounded at Rock Town in Maryland County in the War of 1893, and whereas it is not the policy of the Government to forget those, who have been wounded in the defence of this Country,

Therefore, it is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature ascembled.

SEC. 1. That from and after the passage of this Joint Resolution, the sum of Forty eight (\$48.00) dollars per annum is hereby allowed to Richard Barrett as a pension for injuries received at Rock Town in Maryland County in the year 1893. And the Secretary of the Treasury, under warrant of the President, is hereby authorized to draw for the same out of any money not otherwise appropriated.

Any law to the contrary notwithstanding Approved January 2nd, 1903.

Joint Resolution prohibiting the interference of the Court of Civil Jurisdiction in staying executions, or granting time to de-linquents who have been tried at a Court Martial and against whom judgment of said Court has been pronounced.

Whereas the method pursued by the Court of Civil Jurisdiction in granting stay of Execution, or time to delinquents who have been tried and Judgments awarded against them by Court Martial as well as obstructing the 10

enforcement of military authorities against delinquents and Whereas it is the intention of the Government that the citizens soldiery shall duly observe and perform the military duties enjoined upon them, or delinquents required to satisfy the Judgment of the Court Martial.

Therefore it is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1. That from and after the passage of this Joint Resolution it shall not be lawful for any Judge or Court of Civil Jurisdiction to interfere with Judgements awarded by Court Martials against delinquents by granting them time or stay of execution; but judgements of Court Martial pronounced against delinquents shall be enforced by the proper military authority without reference to the Civil Court provided that nothing in this Joint Resolution shall be so construed as to prevent the supposed rights of the writ of Habeas Corpus and appeal.

SEC 2. Where said delinquent shall fail or refuse to pay the fine and cost assessed against him by the Court Martial, he shall be committed to prison by either the Judge of the Monthly and Probate Court, or the Judge of the Court of Quarter Session and Common Pleas, and shall be required to work for the Government sufficiently long to satisfy the fine and cost against him at the rate on One

(\$100) dollar per diem.

All monies arising from this source shall be used for the improvement of the Regiment to which said Delinquents belongs

Any law to the contrary notwithstanding Approved January 2nd, 1903

Joint Resolution reimbursing one Heary F. Johnson of Montserrado County.

Whereas the said Henry F. Johnson has proven to the Legislature that he was in possession of one Bill against this Government to the amount of Fifty five (\$55.00) Dollars, the sum being the balance for services rendered in the Garrison at Suchn, and unfortunately said bill was destroyed on its way to the Secretary of the Treasury for payment by one William Wilson who was drowned in the Saint Faul River.

Therefore it is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

That from and after the passage of this Joint Resolution the sum of Fifty five (\$55.00) Dollars be and the same is hereby appropriated and the Secretary of the Treasury be and he is hereby authorized under warrant of the President to draw for the same out of any money of the Public Treasury not otherwise appropriated.

Any law to the contrary notwithstanding Approved January 2nd, 1903.

Joint Resolution granting an Annuity to Mrs. R. R. Russell of Clay Ashland St. Paul's River Montserrado County.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1st. That from and after the passage of this Joint Resolution Mrs. R. R. Russell of Clay Ashland Montserrado County be granted an Annuity of the sum of (\$60,00) Sixty Dollars per Annum, and the Secretary of the Treasury is hereby authorized under warrant of the President to draw for the same out of the monies of the Republic not otherwise appropriated.

Any law to the contrary notwithstanding.

Approved Jany. 12. 1903.

An Act to encourage Immigration.

Whereas the petition of the Colored "National Immigration Association" of Atlanta Georgia, United States of America shows that should this Government render them certain aid. as hereinafter mentioned, they will thereby be enabled to purchase and put into operation a suitabled Steamship to ply between the United States of America and this Republic, chiefly for the purpose of bringing Immigrants; and whereas it should be the policy of this Government to do whatever it can in a reasonable way to swell and increase its population by helping to facilitate the convenience of travelling between the two countries, Therefore;

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1st. That from and immediately after the passage of this Act, the sum of Twenty five Thousand Dollars be, and the same is hereby appropriated, out of any money not otherwise appropriated, for the purpose of assisting the Col-

ored "National Immigration Association" Atlanta, Georgia, United States of America, to purchase and equip a Steamship for bringing Immigrants of African decent from the United States of America, the West Indian Islands, Central and South America to Liberia, as well to carry and bring cargo and freight, provided, that in no case shall the money above appropriated be used or drawn until after notice shall have been given to the President and Secretary of the Treasury of this Republic, by the President and Treasurer of the said Association, that the remainder of the money necessary to complete the purchase and equipment of said Steamship, is in the hands of the said Association, ready to be paid on said Steamship. And provided further, that notice shall be given to the President and Secretary of the Treasury of the Republic, by the owner, person or hrm from whom said Steamer is to be purchased that he or they are ready to sell or dispose of said Steamer, and that the only thing remaining to be done in order to complete the transaction, is that this Government pay over to them, the above mentioned sum of money, in which case the Secretary of the Treasury under the warrant of the President of this Republic shall place in the hands or at the disposal of of the Liberian Consul General in the United States, the sum of money herein appropriated or so much thereof as may be required for that purpose, and direct him to pay the same over to the person or firm from whom the Steamer is to be purchased, and to see that the rights of this Republic are protected in the transaction.

Sec. 2ND. It is further enacted that there shall be a board of Commissioners appointed consisting of five members two of whom shall be citizens of this Republic and appointed by the President of the same; the third to be appointed by the Liberian Consul General in America. The other two by the Colored "National Immigration Association." The said board of Commissioners shall in connection with the said Association have general supervision and control of said

SEC. 3RD. It is further enacted, that the Covernment of Liberia, shall have an interest in said steamer in proportion to the amount of money she may pay on the same at the time of purchasing said steamer. The title there shall pass to the Colored "National Immigration Association," provided that the said Association shall then and there enter into a contract with this Government, through the Liberian Consul General in America, that the said Association will continue in the business of sending Imm grants to this country, and provided further that in the event he said Aassociation should

ever abandon the work above mentioned, then and in that case the absolute ownership of said steamer, shall pass to the Liberian Government. And in no case shall said steamship be sold, or otherwise disposed of without the knowledge and consent of the Liberian Government expressed by the proper authority.

An Act granting pecuniary aid to the A. M. E. Church in the Republic of Liberia.

It is enacted by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1ST. That from and after the passage of this Act, the sum of Five hundred dollars be, and the same is hereby appropriated for five years to aid the A. M. E. Church in the maintainance of a school when the building is completed and the school in actual operation.

Sec 2ND. The Secretary of the Treasury is hereby authorized under warrant of the President to draw for the same

out of any money not otherwise appropriated.

Any law to the contrary notwithstanding. Approved January 10th, 1903.

An Act making an appropriation to build a Highway.

Whereas a petition from J. H. Green, Managing Editor of "The African League" and others, showing that they intend to establish a new settlement in the Interior, the place not yet being located; and whereas the said petitioners pray that an appropriation be made for the purpose of building a Highway to said settlement and whereas the Legislature feels that is the duty of the Government to assist in this laudable and praise-worthy undertaking, Therefore

It is enacted by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1ST. That from and after the passage of this Act, the sum of Two thousand and five hundred dollars be and the same is hereby appropriated for the purpose of building a Highway to the place to be located for the establishment of the Settlement to be known as "Liberia City." And as soon as

said place shall have been located, the Secretary of the Treasury, under warrant of the President, is hereby authorized to draw for the purpose above mentioned out of any money not otherwise appropriated.

Any law to the contrary notwithstanding.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1. That S. W. Seton, President, B. N. A. Kerly, Vice President, H. H. Morrell, Recording Secretary, H. T. Messenger, Corresponding Secretary, Abraham W. Savage, Treasurer and other officers and members of said Bedell's Peace Conference of Maryland County, and such others as may be hereafter connected with them be, and they are hereby constituted and declared a body politic and corporate under the name and style of Bedell's Peace Conference of Maryland County, Republic of Liberia, and shall be capable in law to receive and hold real estate and personal property to the value of Two thousand dollars, for the use and benefit of said Conference, and shall have perpetual succession of officers and members, and as such may sue and be sued, plead and be impleaded in any of the courts of this Republic having competent jurisdiction.

SEC. 2. It is further resolved that the said Conference is permitted to do all other things done by similar bodies corpo-

rate.

Any law to the contrary notwithstanding. Approved January 12, 1903.

Joint Resolution appropriating an amount to assist the citizens of Louisiana in Montserrado County in opening a road between that Settlement and Fendel.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1. That from and immediately after the passage of this Joint Resolution, the sum of one hundred and fifty dollars (\$150.00) is hereby appropriated to aid the citizens of

Louisiana, in the County of Montserrado, in opening a road from that Settlement to Fendel.

SEC. 2 And the Secretary of the Treasury, under warrant of the President, is hereby authorized to draw for the same out of any money not otherwise appropriated.

Any law to the contrary notwithstanding.

Approved January 12, 1903.

Joint Resolution pensioning one Nimley of River Cavalla, Maryland County.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1. That from and after the passage of this Joint Resolution, Nimley of Cavalla, Maryland County, be pensioned the sum of Ferty-eight (\$48.00) dollars per annum, and the Secretary of the Treasury, under warrant of the President is hereby authorized to draw for the same out of any monies of the public Treasury not otherwise appropriated.

Any law to the contrary notwithstanding.

Approved January 12 1903.

Joint Resolution making an appropriation for repairs and improvement in the Post Offices at Harper, Maryland County; Grand Bassa, and Sinoe Counties.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1. That from and after the passage of this Joint Resolution, the sum of Six hundred (\$600.00) dollars be, and the same is hereby appropriated for repairs and improvements of the Post Office at Harper, Maryland County, and Five hundred (\$500.00) dollars for repairs and improvements of the Offices of Bassa and Sinoe Counties, respectively.

SEC. 2. That the Secretary of the Treasury be, and he is hereby authorized under warrant of the President, to draw for

the same, out of any money not otherwise appropriated.

Any law to the contrary notwithstanding.

Joint Resolution fixing a special Tariff on Margarine and stained Butter.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1ST. That from and immediately after the passage of this Joint Resolution the duty on all Margarine and stained butter be (10) ten cents in gold, copper, or silver coin on every pound, ordered into this country, or proceeds from vessels coming into any of the several ports of entry.

SEC. 2ND. And it is further resolved that any vendor wishing to sell Margarine or stained butter must pay a special license to this Government of Twenty dollars per annum in gold.

copper, or silver coin.

SEC. 3RD. It is further resolved that any person or persons who shall be found selling Margarine or stained butter, without having complied with this Joint Resolution, shall be deemed guilty of a misdemeanor, and shall before any Court of competent jurisdiction forfeit and pay the sum of Fifty dollars in gold, silver and copper coin one fourth of which shall go to the informer, and the (1) three fourths to the government, and all the Marg rine and stained butter in the possession of the vendor or vendors informed against be contiscated, under the law of confiscation

It is resolved by the Senate and House of Representatives of, the Republic of Liberia in Legislature assembled.

SEC 1. That from and after the passage of this Joint Reso lution, the Widow and heirs of st nd M Perry, a citizen of Maryland County be pensioned the sum of Seventy five (\$75.00) dollars per annum, and the Secretary of the Treasury is hereby authorized, under warrant of the President to draw for the same out of any monies in the public Treasury, not, therwise appropriated.

Any law to the contrary notwithstand ng. Approved Jany, 14 h, 1 o3.

Joint Resolution relating to Debtors.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Leg. h. u. ass mb ed.

SEC. IST. That from and after the passage of this Resolution there shall be built in each County within the Republic in the City, a durable house or a room in the upper part of the several jail houses, called a Debtors Hall.

Sec. 2ND. That the above named hall shall be to place Debtors in and not thrust them in the cells and dungeons of Murderers, Burglars and all such other persons committing

criminal offences.

The duty on Pork shall be one dollar and twenty five cents, per Barrel of (200) Two hundred pounds. The duty on common Rum and Gin shall be one dollar

per Gallon proof, absolute gold.

The importer shall present his invoice to the Collector of Customs, and make a declaration that the Lumber imported is for his private use, and not intended for sale; said declaration shall be supported by an affidavit a copy of which shall be filed in the Custom House, which shall be used as evidence against the importer attempting to sell or selling any such Lumber crdered for private use within the meaning of this Act; and if proven the Lumber shall be confiscated, to the Republic of Liberia and a fine of one hundred dollars for each offence, be imposed upon said importer, recoverable before any court having competent Jurisdiction.

SEC. 1. That from and immediately after the passage of this Joint Resolution no Referee from any tribe shall be admit-

ted to a seat in the House of Representatives of this Republic, unless the tribe be represented shall pay a tax of (\$100.00) one hundred dollars per annum prior to the time of his taking his seat in the House of Repr sentatives, said taxes to be paid to the tax Collector or Collectors as provided for in the above

cited Joint Resolution.

SEC. 2. It is further resolved, that should any Superintendent grant certificate to any one as Referee to the House of Representatives without a receipt from the Tax Collector showing full payment of the amount of tax herein required, he shall be held responsible to the Government for the said amount of taxes the amount thus due shall be made up by the House of Representatives at the end of the session and refer the same to the Secretary of the Treasury, who shall in making up the warrant in payment of the civil List deduct such amount or amounts from the salary of the Superintendent issuing such certificates against the provision of this Joint Resolution.

SEC. 1. That from and after the passage of this Joint Resolution it shall be unlawful for any Foreigner or Foreigners to undertake the work of prospecting for gold or other precious metals, stones or minerals of other kinds in either of the above named Counties except under provisions

herein mentioned and directed.

SEC. 2. It is further resolved that in all cases except for lawfully Chartered and Registered Companies no Foreigners shall engage in prospecting for Minerals etc. etc. in the Counties of Sinoe and Grand Bassa unless he or they obtain consent of the President of this Republic to do so. and in case permissions be granted before such person or persons be allowed to go to the interior, he or they shall enter into Bond with reliable security, that he or they will do no act tending to disturb the Natives as to excite them to do Acts of disloyalty to this Republic, said Bond shall be Three thousand dollars signed and witnessed by at least two witnesses, and further it shall be required of such speculator or speculators to pay for Licenses to prospect in either of the within named Counties the sum of \$ 1000.00 dollars in gold yearly payment in advances.

SEC. 3. It is further resolved that the right of prospecting is intended and is hereby understood and restricted to the act of investigating, to search for, to collect samples for testing, and not the work of mining or searching except for such specimens. Any person or persons violating the provision of this resolution shall by deemed guilty of misdemeanor, and on trial and conviction before any court having competent jurisdiction shall severally pay a fine of not less than Four Thousand dollars and cost of prosecution.

Joint Resolution respecting a square of land known as Coloniaution reserve in the Township of Careysburg.

SEC. 1. That immediately after the passage of this act, the above mentioned act found, on page thirty two of the Legislature of the Republic of Liberia of 1901 and 1902, be and the same is hereby repealed.

An Act amendatory to the Joint Resolution passed and approved January 16th 1897.

It is enacted by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1. That, after the expiration of the concession granted Augustus Humplmayr, it shall be forbidden for any person in the Counties of Montserrado, Grand Bassa, Sinoe, Maryland, and the Territory of Grand Cape Mount to go about soliciting the natives, or Americo Liberians citizens to leave the district or counties to immigrate as laborers to any place outside the Territory of this Republic, before they shall have taken out license to do so. For said license, they shall pay the sum of Two hundred and fifty dollars gold annually into the Sub Treasury of the County in which he or they desire to operate. The license thus obtained shall not be transferred to any one else; the penalty for the violation of section first, shall be a fine of Two hundred dollars and six months imprisonment; one half of the fine is to go to the informer.

Sec. 2. Any person, company, or firm employing laborers for services abroad, must give a bond with security of one hundred and fifty dollars for each laborer; to this effect; that he or they will return said laborer to the port in this Republic from which he or they were taken two months after

the time he or they were engaged for, expires.

Those that die, a certificate of his, or their death must be presented properly certified to, under oath; the failure to present said certificate, two months after the time they were engaged for expires, shall be fined, one hundred dollars for each laborer yearly, until he returns or the certificate be presented; but the Executive Government may notwithstanding the above section issue regulations tending to secure the same end.

Sec. 3. A proper and correct register must be kept by name in a book of each laborer shipped, day and date the ime shipped for, also his or their returing by the Ship-

ping Master. Any person of persons company, or firm, having laborers to ship must notify the Shipping Master at the place the laborers are to be shipped from, two days before they are ready to be shipped. No laborer under Twenty one years of age shall be shipped. The ages to be determined by the Shipping Masters. The failure to keep said Register, shall be a fine of Five Hundred dollars and dismissal from office. The above penalty shall be enforced by any court of this Republic having competent jurisdiction.
Sec. 4 The fee per head for each laborer, shall be as

follows:

From Montsefrado County, "Territory G. C. Mount, " Grand Bassa County, "5.00.
" Since County "5.00. " Maryland County, "5.00.

SEC. 5. That the entire amount of money accruing from the shipment of laborers shall be set apart for affording protection to the laborer shipped, and for the enforcement of order on the coast; the foregoing sections shall not be so understood as to include laborers for working on ships.

Sec. 6. The Shipping Master fee, after the thirty first of December 1903, shall be twenty five cents for each person shipped by him. The Shipping Master of the different counties shall give each a bond of Two Thousand dollars, and immediately after the money is collected, they shall turn the same over to the Sub Treasurers of the counties; provided that nothing in this Act shall be so construed as to prevent the Executive Government from making such regulations, relative to the collecting and paying the money arising from this branch of the revenue into the different Sub Treasuries, as shall better facilitate the carrying into effect the intention of this Act; but ho arrangement shall be made to prevent the Shipping Master from receiving his fee apon each laborer shipped from his County at the time of his or their shipment. The said ShippingMaster shall report as all other reporting officers; said report must be made out in criplicate form, one to be forwarded to the Court of Quarter Sessions and Common Pleas, one to be forwarded to the Bureau of Statistics, and one to the Secretary of the Treasury, on failure to report, he shall be fined not less than five hundred dollars- and forfeiture of his bond.

ACTS.

An Act to incorporate the Protestant Episcopal Church of Crozierville in the County of Montserrado.

It is enacted by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 1ST. That Edward Hunt, Rector, G. S. Padmore Senior Warden, S. Christopher Clark, S. Solomon Eastman, Josiah Cox, J. H. Cox, John C. Brathwait and J. N. Carter Vestrymen all of the settlement of Crozierville in the County of Montserrado and Republic of Liberia, and their successors in office together with such as now are, or hereafter may become members, are hereby constituted a body corporate and politic by the name of 'Christ Church," with power to take hold and possess property real and personal, that may now or shall be hereafter acquired by purchase, gift, devise or bequest, with full power to sell and convey the same, subject to the provisions and conditions of this Act.

Sec. 2ND. That the said corporation shall be granted the privilege to sue and be sued, plead and be impleaded before any Court having competent jurisdiction; and shall be allowed to acquire and hold real and personal estate to the amount of Five thousand nine hundred dollars (\$5900)

Sec. 3RD. That the said Corporation is hereby vested with full power and authority to make and establish such By laws, rules and regulations for their government, and to do all other acts and things usual to be done by similar bodies corpor te and politic, consistent with the doctrine, discipline and worship of the Protestant Episcopal Church in the United St. to of America; provided such By-laws, rules and regulations be not repugnant to the laws or constitution of this Republic.

Sec. 4th. All laws or parts of laws conflicting with this act are hereby repealed

Approved December 23 1903.

An Act respecting Judicial and other Officers.

Where is there should be a better system brought unto the Judiciary with respect to the claims of certain Officers connected with the Court. And whereas this matter, by being annoticed, has caused great slackness of duty on the part of said Officers.

Therefore it is enacted by the Senate and House of Represenlatives of the Republic of Liberia in Legislature assembled.

Sec 181. That from and after the passage of this Act the bills of the Clerks of the several Courts of record within this Republic, the Sheriffs and Marshalls, shall before being presented to the Auditor for his approval, be submitted to the Judge or Judges of said Court or Courts, to be by him or them duly certified as required, to be fully and intelligently itemized, showing specifically and distinctly, each and every item of service therein claimed. And, the provisions of this section shall also apply to County Attorneys, Constables and other persons connected with the Judiciary service; and any Judge of the said Courts of record failing to strictly comply with the provisions of this section, shall, upon the matter being properly shown to the President, be removed from office until the meeting of the next Legislature, who shall investigate the matter.

Sec 2ND. It is further enacted that in no case shall the Clerk of the Court of Quarter Sessions and Common Pleas sign the bills of Justices of the Peace for costs in cases sent forward unless the same be found properly itemized and not until the case or cases shall have found their terminus in said Courts.

SEC 3RD. It is further enacted that it shall not be lawful, and the Auditor is hereby forbidden to audit any bill or bills for persons who have served as Coroner or Coroner's Jurors over the body of any person or persons who shall be known to have been previously sick and died from natural consequences, unless such facts are not known to the Auditor previous to his approval of said bill or bills The Coroner shall be held responsible for said unlawful bills, and shall be liable to prosecution therefor in any Court of competent jurisdiction; and upon conviction shall forfeit his Office and pay a fine of not less than fifty dollars, nor more than one hundred dollars.

An Act to effect constructive notice of legal action upon absent defendants from this Republic.

It is enacted by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1. That from and immediately after the passage of this Act, notice of the pendency or commencement of an action against an absent defendant from this Republic shall be effect ed by the publication of the writ of summons in some prominent newspaper in the County in which action is commenced. for the space of three months after the action is brought or by posting the said summons at the door of the Court House and in two other conspicuous places in the said County or Territory for the same space of time, should there be no newspaper published in the said County or Territory.

It is further enacted that after the publication or posting the said summons as mentioned in the above section for the time therein mentioned, should the said defendant fail to appear on the first Monday of the next ensuing term of Court thereafter, the plaintiff in such action shall be entitled to Judgment pro-con-fesso. This is also intended to apply to defendants whose whereabouts in this Republic are unknown; but shall not apply to such persons who have never resided in this Republic, nor to those who may be temporarily absent

herefrom, either on business or pleasure.

The said drafts are to be drawn out of any monies in the Public Treasury not otherwise appropriated, account General Government, provided that nothing in this Joint Resolution shall be understood as to prevent the Post Master General from inaugurating the Postal Money Order system in either of the aforementioned Counties at any time before the completion of the said Post Offices.

An Act supplementary to an Act chartering the City of B_0 , chanan, Grand Bassa County.

Whereas there are prevailing irregularities at present in the Municipal Government of Buchanan, owing to the Common Council having made certain appropriations far in excess of the revenue of said City, and whereas at present a considerable amount of claims against which, cannot be redeemed owing to a limited revenue; and whereas under a regime and mismanagement of affairs, the purpose of the Legislature in chartering or incorporating this City a body politic has not been met

Therefore it is enacted by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

Sec. 187. That the Salary of the Mayor shall be not more than Seventy five dollars per annum; Treasurer not more than Fifty dollars; Common Councilmen not more than Thirty dollars, each; Street Commissioner Upper Buchanan, not more than One hundred dollars; Street Commissioner Central Buchanan not more than One hundred and fifty dollars; Street Commissioner Lower Buchanan not more than One hundred and fifty dollars, and the City Clerk not more than Fifty dollars, per annum.

Sec 2ND. In all cases where the services of an Attorney at Law are required to guard the interest of the City, the County Attorney shall act, for which he shall receive a remuneration of not more than Fifty dollars, per annum.

SEC 30D. That the Superintendent of the County shall, at as early a date as practicable, appoint three discreet persons for the purpose of registering the entire indebtedness of the City, which, when done, shall be submitted to the Mayor, to be paid by the Treasurer of the City, as soon as it is convenient so to do, provided the claims thus held, are found to be legal.

tic and corporate, under the name and title of the "Trustees of the College of West Africa" and henceforth shall be styled and known by that name; and by that name and style to remain and have perpetual succession, with power and authority to contract, sue and be sued, plead and be impleaded to hold, purchase and convey, as well as mortgage or hypothecate property, real, personal and mixed, to the amount of One hundred thousand (\$100 000 00) dollars; to have and use a common seal and to alter the same at pleasure, to make, alter from time to time such byelaws as they may deem necessary for the government of said Institution and its officers.

SEC 2 It is further enacted that the Missionary Society of the Methodist Episcopal Church, an incorporated institution in the State of New York U. S. A., its Officers and Board of Managers together with the Bishop of Africa for the Methodist Episcopal Church is hereby legally created and constituted a Board of Trustees of the College of West Africa in the United States, acting conjointly with the Board in Liberia.

Sec. 3. It is further enacted that the President of the College of West Africa by virtue of his office shall at all time be a member of the Board of Trustees in Liberia.

Sec. 4. It is further enacted that the Trustees in Liber shall have the power to fix the time and place of their regular meetings, to elect the usual officers in such corporate bodies and to make all necessary bye-laws for the regulation of their business and meetings. There shall be appointed by the President of the Board an Executive Committee consisting of Five members of the Board of Trustees.

The President of the College shall be exofficio Chairms of said Committee. The said Committee shall supervise subaffairs as pertain to the general welfare of the College, which require special consideration during the interim of pregular meetings of the Board, except in matters of instruction and discipline or other matters that legitimately fall within

purview of the Faculty.

regular members of the Board of Trustees, besides the Board of Africa for the Methodist Episcopal Church and I resident of the College. The persons hereinbefore name thall constitute the first Board of Trustees and in them at their successors conjointly with the Missionary Society the Methodist Episcopal Church, its officers and Board Managers, all power is hereby vested. The Board of Trustees in Libera, iter the approval of this Act shall by be divided into three classes of seven each.

The first class shall hold office until the first regular meeting of the Board in 1905, and then at that first regular meeting and each year thereafter the said Board shall elect by ballot seven Trustees, and at no time shall less than three members of the entire Board be members of the Liberia Annual Conference, and two thirds of said Board shall be members of

the Methodist Episcopal Church.

Sec. 6. It is further enacted that the Missionary Society of the Methodist Episcopal Church its officers and Board of Managers, together with the Bishop of Africa for the Methodist Episcopal Church conjointly with the Board of Trustees in Liberia and their successors shall be competent in law and equity to take to themselves in their said corporate name, real, personal or mixed estate, by gift, grant, bargain and sale, conveyance, will, devise or bequest to the amount of one hundred thousand dollars(100,000.00) of any person or persons whomsoever, and to place out at interest or otherwise, dispose of same for the endowment, use and support of the College, and in such manner as shall seem to be most beneficial to said Institution.

Sec. 7. It is further enacted that the Bishop of Africa for the Methodist Episcopal Church, as the representative of the Missionary Society may act for said Society, in all matters which pertain to the College, wherein said Society is conterned, and by virtue of his office shall be ex-officio Chair-

man of the Board of Trustees in Liberia.

SEC. 8. It is further enacted that the Missionary Society of the Methodist Episcopal Chuch, its officers and Board of Managers conjointly with the Board of Trustees in Liberia, shall elect the President of the College on the nomination of the Bishop of Africa for the Methodist Episcopal Church. They shall also elect on the nomination of the President of the College such Professors, Tutors, Assistants and other officers of instruction and government of the College as they shall deem necessary; the emoluments, responsibilities and term of their respectives officers to be fixed and determined by the Bishop of Africa for the Methodist Episcopal Church and the Missionary Society or a special Agent or Representative, whom they may appoint and the Executive Committee of the Board of Liberia.

SEC. 9. It is further enacted that the College of West Africa shall be opened to all the youths of Liberia and parts adjacent, irrespective of religion, sex or parentage; in the broadest sense it is denominational, but in no sense sectarian. It shall aim to impart thorough and practical knowledge in the following departments Collegiate, Theological, Industrial, Normal and Military,

SEC. 10. It is further enacted that the Missionary Society of the Methodist Episcopal Church, its Officers and Board of Managers together with the Bishop of Africa for the Methodist Episcopal Church conjointly with the Board of Trustees in Liberia, shall have power to establish in connections with the College, to organize and control, such preparatory schools or seminaries as it deems necessary.

The Board of Trustees in Liberia shall be further empowered to confer such literary, scientific or professional degrees and diplomas, regular and honorary, as are usually conferred by regular institutions of learing; provided however that no degree shall be conferred or diplomas issued without the recommendation of the President and Faculty of the College

SEC. 11. It is further enacted that this Act shall take ef.

fect from and after its passage.

The duty of said Officer shall be to promote the interest of agricultural education and investigation in the Republic; to collect information with regard to the condition, prospect and harvest of the principal crops and forest products; to make investigations and disseminate information concerning the feasibility of extending the demands of foreign markets for the agricultural and forest products of the Republic; to purchase, if necessary, and distribute valuable seeds, and to arrange for and supervise experiments with respect thereto. The salary of said Officer shall be Five hundred (\$500.00) dollars per annum

Sec. 3Rb. It is hereby made the duty of the Townships at their annual October meetings to appoint a committee of three experienced farmers to assist and cooper to with the Com-

missioner in the discharge of the duties indicated above. The Committee will receive no pay. In case the Town meetings do not appoint the Committee, the Commissioner will then do so.

SEC. 4TH. The Secretary of the Treasury shall place at the disposal of the Bureau, the sum of Five hundred dollars (\$500.00) annually to be expended for literature, seeds and experimental purposes.

Any law to the contrary notwithstanding, Approved January 30, 1904.

Joint Resolution Incorporating the No. 1 Union Brass Band Coll pany of Hartford Grand Bassa.

It is resolved by the Senate and House of Representatives the Republic of Liberia in Legislature assembled.

SEC. 1, That from and after the passage of this Joint Resultion, J. W. Diggs, Jr. Pres. John T. Barnard, Band Mast J. E. Clark Assistant Band Master, James R. Clark Secretar C. A. Reeves Tleasurer, R. L. Griggs, J. J. Griggs, S. Smith, W. J. Forte and others of Hartford in the County Grand Bassa, and such other persons as may become med bers of said Brass Band, are hereby declared a body policorporate under the name and style of the No 1 Union Brand Company of Hartford, and by that name and style, should be sued, plead and be impleaded in any courts of or petent jurisdiction of this Republic; to make and ordain should laws of this Republic and to hold real and personal pretty and do such things as are done by corporations of a nature.

Any law to the contrary notwithstanding. Approved January 30th, 1904.

An Act permitting Foreigners residing at ports of Entry to be coastwise, at places not ports of Entry.

It is enacted by the Senate and House of Representative the Republic of Liberia in Legislature assembled.

Sec. 1. That foreign merch nt-, and traders residing

Ports of Robersport, Monrovia, Marshall, Buchanan, Greenville and Harper, having establishments at said ports are permitted to tride coastwise at points not ports of Entry under such regulations as may be formulated and published by the Executive Government from time to time under the provisions of this act.

SEC. 2ND. It is further enacted that Foreign Merchants and traders, having establishments in the above named ports, may trade coastwise and may establish factories at points on the coast not ports of Entry, where the Government may deem it safe to allow such contact with the aboriginees, providing however, at all such points the factors shall be Liberian citizens. Nothing in this act shall be so construed as to prevent Foreign, owners or agents from visiting said factories and taking stock cases of fraud, embezzlement, cheat or other acts of dishonesty, before any court of competent jurisdiction, and punished as provided for in the common law and other laws in force in the Republic.

SEC. 3RD. It is further enacted that the annual license for trading at the points above referred to shall be the same as are now paid for license to trade at regular ports of entry; Rum license not excepted. All licenses to trade at said points shall be paid into the County Treasury where such points are. The license shall be granted as in other cases by the clerk of the Court of Quarter Sessions. All license money accruing from said trading points shall go to the chiefs and headmen at said points, who shall covenant with the Government before receiving the same, that they will do their best to induce unobstructed trade from the Interior to such points; to afford aid in the apprehension of all robberies and to protect and defend factors, owners and Government officials at said points; and on failure to do so they shall lose the benefit of the license money herein appropriated for them.

Sec. 47H It is further enacted that in all cases where foreigners enjoying the benefit of this act, so conduct themselves as to incite the natives to rebel against the Government or where from the hostile attitude of the natives to traders or Government, danger threatens, the Government reserves to itself to interdict trade and intercourse at such points, until the law and authority of Government is duly recognized and obeyed by the Natives at such points, and may order the removal of Foreign traders and Factors from such points, until then. And in no case shall indemnity be claimed by foreigners for such removal nor for buildings and improvements at such points. And should any firetory or factor es

be destroyed by fire or otherwise, the Government shall investigate the cause and punish any person or persons found guilty of such depredation according to the laws of the Republic, but in no case shall foreign owners claim any indemnity beyond such as is granted under the laws of

Liberia in such cases provided.

Sec. 5th. It is further enacted that at trading points along the Coast, Merchants, Traders, or factors may alone hoist and float their house flags, and at all such trading points the National flag of Liberia shall constitute the standard of all such trading points. To this end the President shall cause the chieft ins of all such points not Ports of Entry open to trade, to be furnished with a Liberian flag to be hoisted daily at such points. Any merchant, trader or Factor violating the provisions of this section, may be held liable in any court of competent jurisdiction of the Republic, and on proof and conviction shall be fined in a sum not less than fifty dollars for each offense.

SEC. OTH. It is further enacted that all arrangements for land on which to erect factories or houses, shall be submitted to and approved by Government, and not with the natives on the coast. And any person employed in factories at such points who shall be found creating disturbances among the Natives shall be deported by order of the Government to such part from

which he was engaged.

SEC. 7th. It is further enacted that all produce bought at said points shall be conveyed to the regular ports of Entry above named and shipped from thence abroad under the revenue

law of the Republic.

SEC. 8th. It is further enacted that all goods imported for trade on the coast, shall be landed at one of the ports about named and duties paid on same and transhipped to the coast from said ports.

Any law to the contrary notwithstanding. Approved Jan'y 30th, 1904.

Joint Resolution authorizing the cleaning out of Jar-baker's Creck also for the opening of a road on the North West Boundary line to the end of our limits in the interior and to place fortifications and Public Force on same.

It is resolved by the Senate and House of Representatives the Republic of Liberia in Leg.slature assembled

SEC 1ST. That from and after the passage of this Joint Resolution the sum of five hundred (\$500) dollars is hereby appropriated for the cleaning out of Jar-baker's creek, and five thousand

(\$5000) dollars for opening the road and bridging the creeks on said road, that is allowing one thousand dollars (\$1000.) for each tity miles of road, and bridging the said road; to commence at Larweelah on the Manoh River and to run on the

boundary lin : or as near as possible.

SEC. AST. The President is directed to establish on said road at reasonable distances apart, fortifications with suitable Police Force, one Chief Commissioner and as many Sub Commissioners as may be necessary, the Sub Commissioners and Police Force are to act under direction of the Chief Commissioner.

Sec 3ND. That as there is no lawar present defining the duties of Commissioners and Police Force on said road, instructions

must be given by the Executive Government.

SEC. 4TH. That for the maintainence of Commissioners, officers and Police Force, as well as the pay of same, the sum of Ten thousand (\$10000) dollars pay, and for maintainence for carriers three thousand (\$3000) dollars be and the same is hereby appropriated, and the Secretary of the Treasury is hereby directed to draw for the within several appropriations under warrant of the President, out of any monies not otherwise appropriated.

Any law to the contrary notwithstanding.

Approved January 30th. 1904.

Joint Resolution authorizing and directing the President to open certain roads in the County of Maryland.

Whereas, owing to the need of public roads in the interior and a better system of communication to be held between the Government and our interior native population, who left to themselves are continually at war with each other, and being so far beyond the trading centers of Liberian traders; the greater portion of the market products of our hinterland are either wasted or decoyed away to the adjacent foreign Colonies, and whereas the Government should do something by way of opening regular commercial communication with the Natives of the interior, and inaugurate some plans and means, whereby the natives may become more identified with the Government, and thereby, more safely secure the territory of our hinterland.

Therefore it is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC 1ST. That from and immediately after the passage of this Joint Resolution, the President be and is hereby authoriz-

ed and directed to open in the County of Maryland oppublic highway extending from the port of Webo on the Cavalla river interiorward to the Glaion section of the Pracountry and to establish on the said road thereon mon stations, thereby dividing this vast extent of country in three or more districts.

Sec 2ND It is further resolved that one Commissioner shall be appointed to reside at each of said stations, whose dustable be the same as the Native African Commissioner, with his or their districts, and shall received the sum of this hundred dollars per annum as his salary and one hundred.

dollars for traveling expenses.

SEC 3RD. It is further resolved that the President beam is hereby authorized and directed to furnish each or sum of said commissioners as shall be found necessary with suitable police force to act under the direction of said Commissioner or Commissioners in keeping and preserving peace on the said road and among the several tribes in the section of the Country. The said police to receive each compensation, not more than eight dollars per month, with board and lodging at said Station free.

Sec 47H. It is further resolved that the President be at is hereby authorized and directed to open a highway leads from Sheppard's lake in the County of Maryland to Dema loo on the Cavalla river, thereby connecting the two wats ways for the convenience of trade and travel between Happe

Cape Palmas and the Cavalla river.

SEC 5TH. And the sum of Sixteen thousand dollar (\$16.000.00) be and is hereby appropriated to open these road leading into the interior from the Port of Webo. As the sum of one thousand and five hundred dollars (\$1500.00 be and the same is hereby appropriated for the road between Sheppards lake and Demar-loo, and the Secretary of the Treasury be and he is authorized and directed to draw the same under warrant of the President out of any General Government fund not otherwise appropriated.

SEC 6TH It is further resolved that the sum of one dollar payable in coin or Liberian currency be and he is here levied on all male inhabitants in the County of Marylan from the age of sixteen to sixty years, which shall be a lected by a collector or collectors to be appointed by a President, and paid into the Sub Treasury of said Count as a special fund to be used towards aiding the carrying in

effect the provisions of this Resolution.

Any law to the contrary notwithstanding.
Approved January 30, 1904.

Joint Resolution amending the patent granted J. H. Hughes and J. H. Wilkins of Grand Bassa County, Approved January 30, 1902.

It is resolved by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled

Sec. 187. That from and after the passage of this Joint Reolution the said J. H. Hughes and J. H. Wilkins are hereby granted the further right of instituting legal action against any person or persons interfering with the aforesaid right granted them in any of the Courts of the Republic having competent Jurisdiction for a damage of not more than One thousand dollars (\$1000.00) the said interference is so understood as to mean, the gathering buying and shipping the said Vegetable Ivory from this Republic.

Sec. 2ND. It is further resolved that the said J. H. Hughes and J. H. Wilkins shall not transfer the aforesaid rights thus granted to any person or persons, firm or firms without the

approval of the Executive Government

Any law to the contrary notwithstanding.

Approved January, 30, 1904.

And Act repealing an Act entitled an Act Amendatory to the Joint Resolution passed and Approved January 20th 1897

It is enacted by the Senate and House of Representatives of the Republic of Liberia in Legislature assembled.

SEC. 1. That from and immediately after the passage of this Act, it shall be unlawful for any person in the several Counties and Territories of this Republic to go about soliciting the Natives or Americo Liberian citizens to leave the country to emigrate as laborers to any place outside the territory of this Republic before they shall have taken out license to do so. For said license they shall pay the sum of Two hundred and fifty dollars (\$250.00) in gold coin into the Sub Treasury of the County in which he or they shall desire to operate, said license shall be given by the Superintendent of the said County upon payment of the above named sum. The license thus obtained shall not be transfer ble to any one else. The penalty of the violation of this section -h Il be a fine of Two hundred dollars and six months imprisonment, one half of the fine to go the informer and the other half to the Government.

Sec. 2. Any persons, company or firm, employing laborers for services abroad must give a bond with security of one.

hundred and fifty dollars for each laborer to the effect, that he or they will return said laborer to the port in this Republic from which he or they were taken, two months after the time of services expires for which they were engaged. In case of death a certificate of his or their death properly certified must be presented, and upon failure to present said certificate two months after the time of engagement expires as above cited they shall be fined the sum of One hundred dollars for each laborer yearly until he returns or the certificate is presented. The provisions of this section shall not apply to the County of Maryland.

Sec. 3 A proper and correct Register must be kept by the Shipping Master in a book, of the name of each laborer shipped, day and date of shipping, also the period of service for, and date of his or their returning. Any person or persons, Company or Firm, having laborers to ship must notify the Shipping Master of the place the laborers are to be shipped to, two days at least before they are ready to be shipped. On failure to keep said register the said Shipping Master shall be fined the sum of Five hundred dollars and dismissed from office. The above penalty shall be enforced by any Court having competent jurisdiction.

Sec. 4. The fee per head for each laborer shipped shall be Five dollars (\$5.00) in gold coin in each of the Counter

and Territories of this Republic.

SEC. 5. That two thirds of the money accruing from the shippment of laborers, and fines for violation of the shipping laws, shall be set apart for General Covernment purposed one half of said amount shall be used for the purposed bringing over Immigrants of a desirable class from Americand the West Indies. The foregoing section shall not be so construed as to include laborers for working on board ships. The fee on such laborers shall be one dollars per head parable in gold. The Shipping Master shall receive from the first day of February 1904 a fee of fifty cents for each by shipped to foreign parts, and for all deck laborers, he shipped to cents (10cts) per head.

Territories shall give a bond of Two thousand (\$20000 Dollars each, and immediately after the money is collect they shall turn the same over to the Sub Treasurers of different Counties and Territories. And no arrangemental be made to prevent the Shipping Master from receivables fee upon each laborer shipped from his County of the ritory at the time of paying said shipping monies into Sub Treasuries.

No Shipping Master shall receive his fee until he exhibits to the Sub Treasurer of his County or Territory, one, at least of the shipping documents, countersigned by the Captain or other person taking laborers or deck boys. The Sub Treasurer shall endorse the paper so presented and this shall be

sent up with the Shipping Master's report.

SEC. 7. The Shipping Master shall report as all other reporting officers, said report shall be made out in triplicate forms, one to be forwarded to the Court of Quarter Sessions and Common Pleas, one to the Bureau of Statistics, and one to the Secretary of the Treasury. On failure to report he shall be fined not less than Five hundred Dollars, and forfeiture of his bond, said reports shall be made quarterly. One third of all revenues accruing from the shipment of laborers; license for shipping and fines for violation of the shipping laws shall be kept in the Sub Treasuries and paid out on County claims under the warrant of the President, and the remaining two thirds set apart by the provisions of Section fifth of this Act shall be forwarded to the Treasury Department at Monrovia monthly by the Sub Treasurers.

All laws or parts of laws conflicting with the provisions of this Act, be and the same are hereby repealed.
