

STATEMENT

Commanders-in-chief of Luftflotten were the highest troop commanders in the German Air Force. The status and authority of these commanders-in-chief, as far as subordinate troops were concerned, were equivalent to those of the commander-in-chief of an army group or of an army.

Until the summer of 1944 they bore the designation of Befehlshaber, but had the authority of an Oberbefehlshaber of an army group or of an army at the front. From the summer of 1944 on they bore the designation of Oberbefehlshaber. No change in their functions and in the extent of their responsibility was effected by this change in designation.

Die Luftflottenchefs waren die höchsten Truppenbefehlshaber der deutschen Luftwaffe. Rang und Befugnisse dieser Luftflottenchefs waren denen eines Oberbefehlshabers einer Heeresgruppe oder einer Armee gleichgestellt, soweit sich dies auf die unterstellten Truppen bezicht.

Bis Sommer 1944 führten sie die Dienststellungsbezeichnung Befehlshaber, hatten aber die Befugnisse eines Oberbefehlshabers von Heeresgruppen oder Armeen an der Front. Ab Sommer 44 erhielten sie die Dienststellenbezeichnung "Oberbefehlshaber"; hierdurch waren keinerlei Änderungen in ihren Aufgaben und Verantwortungsbereich gegenüber früher verbunden.
