- 1. On 15 March 1945 I was on active duty with the United States Navy and it became my official naval duty to serve on the Jegal staff of the United States Chief of Counsel for the Prosecution of Major European War Criminals.
- 2. From them to the date of this affidavit, my duties and responsibilities have included the over-all direction and supervision, on behalf of the U. S. Chief of Counsel, of all photographic evidence to be used in the prosecution of such war criminals.
- 3. The strip of 8 mm. film to be shown to the Tribunal, revealing actual photography by the Germans of inhuman treatment of people within their custody, was received by me in the course of my official duties as described above. The previous history of the film is described in the affidavit of Lt. Col. Roland H. McIntire, CMP, United States Army, attached hereto as Exhibit "A".
- 4. Attached hereto is a brief description of each scene in this film, certified by me to be accurate. ("Exhibit "B")
- 5. Since the film was received by me, it has remained at all times within the exclusive possession and control of my command. It has not been re-touched, distorted or otherwise altered in any respect; we have not even made a copy of it. The film shown to the Tribunal is the original strip received by us.

- I, ROLAND H. McINTIRE, LT. COLONEL, CORPS OF MILITARY POLICE, UNITED STATES ARMY, HEREBY CERTIFY THAT:
- 1. ON OR ABOUT 1st MAY 1945 I WAS ON ACTIVE DUTY WITH THE ARMY OF THE UNITED STATES STATIONED AT AUGSBURG, GERMANY.
- 2. ON OR ABOUT THAT DATE THERE WAS DELIVERED TO ME, BY MILITARY PERSONNEL ON ACTIVE DUTY IN THAT AREA, A ROLL OF 8 MILLIMETER FILM, WHICH HAD BEEN FOUND NEAR AUGSBURG, GERMANY IN THE BARRACKS OF S.S. TROOPS. EXAMINATION OF THE FILM REVEALED, THAT IT CONTAINED PICTURES OF BEATINGS AND MISTREATMENT OF NAKED WOMEN AND OTHER ATROCITIES, ALL IN THE PRESENCE OF AND WITH THE APPARENT CONCURRENCE OF ARMED GERMAN SOLDIERS AND S.S. MEN IN UNIFORM, AS SHOWN IN THE PICTURE.
