PoWs of nationalities other than Russian were to be "released" and handed over to the Gestapo if the High Command, Armed Forces or the District HQ VI . (author of the instruction) issued a special order to that effect (3). If they are suspected of having participated in illegal organisations, etc. they are to be handed over temporarily to the Gestapo for interrogation without being "released".

French, Belgian, and Italian Pows are furthermore safeguarded by the order that they can be handed over for interrogation only if HQ VI consent, but this is not the case in respect to British and American prisoners. (4)

Although they are called "woluntary lebor", they are to be treated as slaves. They have to wear visible badges, they are to be separated from Germans, without any social contacts with them. Special restrictions are imposed on them, such as curfew, prevention from using public convergences, places of public enter-tainment and refreshment. Sexual intercourse with Germans is subject to death penalty. The Security Police is ordered to provide speical brothels, staffed with Polish girls. Most severe penalties are to be inflicted in any case of offence, such as death, commentration camp etc. Spiritual care is severely restricted. In every aspect Poles are to be treated as an inferior race. Germans who have intercourse or love-affairs with Poles, are to be made the object of public defamation before they are arrested and punished or put into concentration camps.

Severe penalties are also to be imposed on Germans who do not comply with the regulations issued. Clerics who do more for Poles than has been permitted are threatened with measures by the State Police.

The fact that the greater part of the preparations envisaged in this plan were to be completed by 15 July 1938 (see Part J "Deadlines") shows that action against Czechoslovakia was planned for the autumn of that year.
