## AGGRESSIVE WAR

Keitol identifies Fuehrer order No. 2 with reference to conduct of war against France and England (438-PS) (p.1 - 2). He cannot identify the signature on the document, but he states that the officer who signed it must have belonged to Gen. Jodl's staff. The contents is familiar to him and he has no doubt about its authenticity. The document is a copy which was retained by the leadership staff of the Wehrmacht (p.2).

Keitel identifies Fuchrer order No. 5 (439\_PS) with reference to treatment of Poland (p.3). He states that this is a copy, but he is sure that this document is correct. He recognizes the signature of Captain Tretha, who attested the correctness of the document. This document was written about one week after the completion of the Polish campaign (p.3). The contents of the document are familiar to Keitel. He thinks that Jodl could give more information about the signature on this document (p.4).

Wilhelm Keitel, 8 September 1945, p.m.

Keitel identifies Fuhrer order No. 8 (440-PS) with reference to invasion of Holland, Belgium and Low Countries (p.4-5). He acknowledged his signature on this document. He claims that the Fuhrer looked this order over and ordered him to sign it. The document is an original order. Since there were several corrections made, he signed the order only "by order of the Fuhrer". He believes he recognizes the signature of Captain Trotha and notations for interoffice use of the Wehrmacht staff. This document originated in late November, 1939 (p.5).

Keitel identifies Fuhrer order No. 9 (441-PS) with reference to economic war against England (p.6). This document is a copy and the correctness is attested to by the signature of Captain Trotha. The contents of the document is familiar to Keitel (p.6).

Koitol identifies Fuhrer order No. 16 (442-PS) with reference to invasion of England (p.7). He recognizes the actual words in the document and acknowledges his own and Gen. Jodl's initials (p.7).

Keitel identifies Fuhrer order No. 18 (444-PS) (p.7-8) with reference to conduct of war against France, the Iberian Peninsula, Atlantic Islands, Egypt, Balkans and Russia. He acknowledgeshis own signature and Jodl's ini initials. (p.8)
