## AGGRESSIVE WARS

Keitel identifies document 461-PS and OKV order supplementing Fuehrer Order No. 34 concerning the war on the Eastern front. He acknowledges his signature. The order was issued after a discussion with Runstedt and other commanders (p.1).

Keitel identifies document 462-PS, Fuehrer Order No.35, concerning strategic instructions. It was signed by an officer, Buchs, who certified the document. Keitel called it a report by Jodl, after the commander in chief, Brauchitsch, had submitted his report (p.2).

Keitel identifies a photostatic copy of document 463-PS, concerning changes in Fuehrer Order No. 35 (Doc.462-PS) (p.2).

Keitel identifies document 464-PS, Order No. 36, concerning the war on the North-Eastern front. He acknowledged his initials. The document is a result of a report by General von Falkenhausen, commander in chief of Norway (p.3).

Keitel identifies document 465-PS, an OKW order supplementing Fuehrer Order No.36 (464-PS). This order was made and signed by Keitel himself. Von Tippelskirch certified Keitel's signature (p.3).

Keitel states that the order in document 466-PS, Fuehrer Order No.37, concerning operations on the North-Eastern front has never been issued. It was first a proposition. Bue he has seen it and he acknowledges his initials and Jodl's initials, who drafted it. It was drawn up after a conference between Keitel, Jodl and Marshal Mannerheim (p.4).

Keitel identifies document 496-PS. This order was issued by the Fuehrer alone and it carries his signature (p.4).
