Alfred Rosenberg, 6 October 1945, p.m.

This session deals mainly with the procurement of labor.

Rosenberg was opposed to the recruiting of labor by force, admits however that the procurement of labor was handled administratively by the organization under his jurisdiction, the quotas being set by Sauckel. he claims he acted under Hitler's orders when extending cooperation to Sauckel. The letters written to Sauckel, however, do not show Rosenberg's disapproval of these methods (p.1-5).

A report received from Nickel regarding the Youth project in Ruthenia (309-PS dated 19 October 1944) is identified by Rosenberg (p.6).

Letter written by Sauckel asking for one million foreign workers, dated 17 March 1943 Ol9-PS is identified by Rosenberg. He admits that he was doing his best to meet the quotas asked for by Sauckel (p.7).

Reproduction of Document O21-PS, dated 12 April 1943, is identified by Rosenberg as having been received by him. The report concerns a conference between Sauckel and others with reference to the manpower situation (p.8,9).

Rosenberg admits that he received complaints through censorshintercepts regarding treatment accorded to the native population. Asked whether he did anything to remady this situation, he refers to other agencies such as the Political Division, or Division for Social Work, who visited labor camps to check on those reports (p.10). In this connection, he refers also to an order issued by him asking for just treatment of workers, Document 194-PS, dated 14 December 1942, being evidence (p.11)-

He identifies signature of H.ierl in Documents dated 20 July 1943 and 13 July 1943, 034-PS, as well as Document 257-PS, setting forth the treatment of Eastern workers in Germany. He admits that the complaints in the document are justified (p.15). Other document 538-PS, dated 16 June 1944 and 7 Ocgober 1942 are identified in the connection (p.17).

As to plans for aggressive action against Russia, a folder prepared in April, June, July, and August is identified by Rosenberg (p. 18).

As to conscription of labor he identifies R-36, containing two documents, one of them is identified as having been written by Bormann (p. 19).

Alfred Rosenberg, 6 October 1945, p.m.

Letter written on 25 March 1945, addressed to Kajum-Chan is identified by Rosenberg. Kajum-Chan was working for the Ministery 1754-PS, (p.20).

Regarding discussions pertaining to the definition of "Jew", a mimeographed document dated May 1942 is identified by Rosenberg.
