His two brothers, Herman and Alvin were partners in the Reemtsma concern. Subject was Married twice.

Work and Political History:

Phillip Reentsma is known primarily as Germany's largest cigarette manufacturer. Her was partner and manager of H.F. and Ph. F. Reemtsma AG, Hamburg, which is said to account for more than eighty percent of German cigarette output. He is said to have built up his business by ruthless methods of cut-throst competition, selling below cost until his competitors were forced to sell out to his concern. 1/

The Reemtsmas are said to have been "inveterate foes" of the Weimar Republic. 2/ At any rate, apparently a typical opportunist, the Reemstmas prospered under the Nazi regime. According to his interview source, Phillip Resentanta subsidized many political parties before 1933, as hismain purpose was the promotion of his business interests. He is said to have maintained relations with Giring, to have made the personal acquaintance of Hitler. after 1933, to have joined the NSDAP and to have complied not only with Nazi regulations concerning the dismissal of Jewish personnel, but to have full-Cilled the perconal wishes of top Mazi Isaders in joining financial enggert in extravegent feet ventures

Work and Political History, contid:

They obtained a digarette monopoly in Danzig and brought many small companies in Germany under their control.

Phillip. Reemtsma in addition to his tobacco interests was connected with leading enterprises in other fields. He was a member of the Board of Directors of the Deutsche Bank, the largest German Bank. Reportedly under indirect control of the Dautsche Bank was the Vereinigte Glanzstoff Fabriken AG, Germany's largest individual rayon concern of which Reemtsma was a member of the Board of Directors. In 1940 he acquired the majority of the stock of the German Afrika steamship line.

Reemtsma held several important positions in the Nazi administration of business. He was head of Fachgruppe Zigarettenindustrie in der Wirtschaftsgruppe Lebensmittelindustrie (Special Group Cigarette Industry of the Economic Group Foodstuffs Industry), which forms part of the corporative organization of German business established by the Nazis in 1934. In this capacity he exercised control over the entire German cigarette production.

Reemtsma was, fur nermore, a member of the Advisory Board (Beirat) of the Reichsgruppe Industrie (National Group Industry), which played an inportant part in controlling German industry. Reemtema was a member of the Industrie und Handelskammer (Chamber of Industry and Commerce) in Hamburg (which was later merged into a gau Economic Chamber) and a member of the Advisory Board (Beirat) of the Deutsche Reichsbank.

Reemtsma received the title of Wehrwirtschaftsführer, which is granted only to keymen in the German war economy who are in excellent standing with the Nazi Party.

Summary

By virtue of his control over the German tobacco industry, as partner, and manager of the largest German tobacco company, H. P. and Ph. F. Reemtsma, and as head of the Special Group Cigarette Industry of the Economic Group Foodstuffs industry, by virtue of his business positions with such important firms as Deutsche Bank, Vereinigte Glanzstoff Fabriken AG, etc., Resmisma plays an important part in determining Nazi economic policies.
