- 1. ANNOUNCEMENT: Pursuant to General Orders No. 300, Hqs U. S. Forces, European Theater, 27 October 1945, the 6827th Military Detachment (Non-Table of Organization) was established for duty with the Office of the U. S. Chief of Counsel. Our Executive Officer, Colonel Robert J. Gill, Infantry, has assumed command. This new detachment will be our own military unit for officer and enlisted personnel assigned to the Office of U. S. Chief of Counsel.
- 2. CHANGE OF ADDRESS WAR CRIMES BRANCH: The War Crimes Branch of the Deputy Theater Judge Advocate's Office informs us that the new address of the branch is: War Crimes Branch, APO 633, U. S. Army. This stresses the importance for personnel of this command to stop nicknaming the Office of U. S. Chief of Counsel "WAR CRIMES". Due to the unfortunate use of this nickname, much time has been wasted in the delivery of official mail and cables which went to the War Crimes Branch instead of to the Office of U. S. Chief of Counsel.
- 3. MESSENGER SERVICE: The chiefs of the newly established sections will kindly send a memorandum to the Administrative Division, Room 172, indicating in which room the "IN" and "OUT" mail boxes will be found for their unit. This will enable the Administrative Division to reorganize the messenger routes. The same applies to the chiefs of the existing divisions if their offices have undergone a change of location as a result of the current reorganization.
- 4. SPECIAL MESSENGERS: The various offices in this building are serviced five times daily by a regular messenger team, consisting of two men. If the amount of paper to be taken out of an office is such that this team cannot take care of it, or if there is any urgency in getting a paper out of an office into another office, it is recommended that you call Extension 61009 and avail yourself of the extra messengers held in waiting there just for that purpose. The above procedure is recommended in preference to requesting that a single messenger be assigned to an individual office.
- 5. STARS & STRIPES: Subscriptions are now  $7\frac{1}{2}RM$ 's. The subscriptions run by calendar months, so that if you subscribe after the first of November, you will not get thirty issues for your money. Subscriptions are now received in Rm 115, repeat 115.
- 6. LAUNDRY SERVICE: Laundry and dry cleaning may be turned in Mondays only at either the Grand Hotel or the Court House, Rm 74, and pickedup on Fridays after 1330. It is requested that those persons not residing at the Grand Hotel avail themselves of the laundry service in the Court House.
