- 1. ATTENTION: ENLISTED MEN: All enlisted men on duty with the Office of U. S. Chief of Counsel having sixty points and over will please report to Lt. Florence Rowand, AC, Adjutant, in Room 172 for an interview.
- 2. HOUSE VISITS BY MEDICAL OFFICER: Because of the increasing number of personnel sick in quarters, it is requested that all personnel requiring medical attention at home will please notify the Dispensary at the Court House by 1000 A.M. Otherwise, except in emergency cases, the Medical Department may not be able to make necessary arrangements for examinations, medicines, or transfer to the hospital when necessary.
- 3. BOOK WANTED: Will the person who took a copy of Rosenberg's Der Mythus des 20, ten Jahrhunderts from Room 297, please return it to that same room immediately?
- 4. ATTENTION: GIRLS ATTENDING DINNER DANCE at Station 2-45, Ansbach, Germany, the evening of 13 November. There will be cars in front of the Court House at 1800 Wednesday, 13 Nov., to take you to the dinner dance.

- 7. NIGHT MOTOR TRANSPORTATION: It is requested that arrangements be made with Lt. Siracusa, Extensions 61182 and 61755, as far in advance as possible, when it is anticipated that motor transportation will be required after midnight. At present one car is kept available from 2400 to 0700, but with the more exacting work schedules at this stage of the trial preparation more transportation facilities may be needed during those hours. This can be provided if there is sufficient advance notice of such requirements.

It is pointed out, however, that the requests for transportation facilities after curfew hours should be limited to transportation between work and billets. With the necessity of making fullest use of our limited transportation facilities, vehicles cannot be kept available after midnight for transportation in violation of curfew regulations, as each driver assigned to a midnight shift reduces the number of drivers available during regular office hours.
