MICROSOFT TEAMS

How to Join the Meeting:

- 1. It is recommended to download the App (but not necessary):
 - a. Apple Devices.
 - b. Android Devices.
- 2. When you click the following link, it will prompt you to choose: Launch App, Download App, or Join by the web. <u>Click here to access the March 18, 2021 Teams meeting.</u>
- 3. Allow access to your mic and camera (this is very important for you to join the conversation).
- **4.** Prior to joining the meeting, it will require you type your name. Make sure your mic and audio are on and click join.

Virtual Meeting Etiquette:

- Test the app and all technology (including camera/video, Wi-Fi, and audio) before the meeting.
- Always have a contingency plan, you may want to download the app to a second device.
- Mute your microphone when you are not speaking.
- Start a comment by saying your name. Not everyone may recognize your voice. This practice also facilitates the work of the person who is taking minutes.
- Be aware of your surroundings: make sure your background is professional and work appropriate.

SUBJECT: Alliance Member Attendance Policy

As an important component of the Downtown Grand Rapids Inc. organizational model, three Alliances (Investment, Livability, and Vibrancy) were created in 2014 to provide meaningful opportunities for Downtown practitioners, employers, partners, cultural institutions, and other stakeholders to be involved in the day-to-day process of improving Downtown Grand Rapids.

In 2017, this model evolved into five citizen Alliances organized to advance the goals of GR Forward:

GR Forward Goal 1 Alliance – advises on programs and projects to reestablish the Grand River as the draw to the City and region.

GR Forward Goal 2 Alliance – advises on programs and projects to develop a true Downtown neighborhood home to a diverse population.

GR Forward Goal 3 Alliance – advises on programs and projects to implement a 21st century mobility strategy in Downtown.

GR Forward Goal 4 Alliance – advises on initiatives to expand economic opportunities in Downtown.

GR Forward Goal 5 Alliance – advises on public space programs and projects that create an ever more welcoming and inclusive Downtown.

Each of the Alliances meets regularly and provides staff with input regarding DGRI programs, projects, incentives, and services. Relative to the fiduciary boards of DGRI (DDA, DID, MNTIFA), the Alliances perform deeper, project-level engagement and report back to the DGRI Board of Advisors and the fiduciary boards with regular updates. The membership of the Alliances each elected their own chairperson, and by virtue of that election, that individual is provided a voting, ex-officio seat on the DGRI Board of Advisors.

Given the important role of the Alliances in advising on DGRI projects, programs, and priorities, regular participation becomes a critical element to ensure continuity, comprehension, and progress. Respective of that need, the Board of Advisors approved in 2014 an attendance policy intended to compel regular participation and, when needed, create a mechanism to make seats available to members of the community whom have the ability to participate regularly. That policy appears below.

DGRI Alliance Attendance Policy

Regular attendance by members of the Downtown Grand Rapids Inc. (DGRI) Alliances is essential to the operations and production of DGRI programs, projects, and other initiatives. DGRI staff and fiduciary boards depend on the concerted efforts of Alliance members both individually and collectively for advisory and participative bases. Further, DGRI Alliance meetings comply with requirements outlined in the Open Meetings Act, and meetings are required to obtain a quorum of members to advance official decisions and recommendations. As such, members of DGRI Alliances shall not be absent to more than two of their respective, normally scheduled Alliance meetings over any 6-month period.

DG RI staff will track attendance records for each Alliance and will notify the respective Chairs in the instance where a member's absences exceed the threshold defined herein. The Alliance Chair will then ascertain the member's justification for excessive absenteeism, and accordingly, report back to the President & CEO if the excessive absences are not justifiable and/or understandable due to either personal or professional obligations. Upon agreement between the Alliance Chair and the DGRI President & CEO that the absences justify removing the individual from the Alliance, the President & CEO will notify the individual that their seat would be better filled by a more participative member.

In the instance that an Alliance Chair demonstrates poor attendance as described herein, the DGRI President & CEO, in partnership with the Chair of the DGRI Board of Advisors, shall make the determination if the absences are justifiable and understandable. In the instance where such absences are deemed to be excessive, the President & CEO shall notify the Alliance Chair of the decision and the corresponding Alliance will be tasked with electing a new Chair.


