MEETING OF THE DOWNTOWN DEVELOPMENT AUTHORITY

September 8, 2021

1. <u>Call to Order</u> – This meeting was called to order at 8:02 a.m. by Chair Rick Winn.

Attendance

2. Approve Meeting Minutes from August 11, 2021

Motion: Ms. Dunn, supported by Mr. McNeilly, moved approval of the August 11, 2021 Meeting Minutes as presented. Motion carried unanimously.

3. Accept August 31, 2021 Financials

Ms. Chapman stated an updated format for sharing financials is now being used and Statement D has been ordered, by project, for ease of review; please notify her if additional changes are preferred. She also stated tax increment revenues have been posted by the Treasurer's Office.

Motion: Mr. Talen, supported by Mr. Avila, motioned to accept Statement D: August 31, 2021 Expenditures. Motion carried unanimously.

Ms. Sieger, Mayor Bliss and Mr. Eddie joined the meeting.

4. Fish Ladder Park Improvements

Mr. Miller presented the Fish Ladder Park repair design drawing, funded in October of 2020 along with other Riverwalk improvements in collaboration with the City. This work is scheduled to be completed by mid-October and includes riprap repair and walkway improvements. This was budgeted in FY22 under River Edge Improvements.

Motion: Ms. Schottke, supported by Mr. McNeilly, moved to approve funding in an amount not to exceed \$35,080 to Dykema Excavators for the Fish Ladder improvement project. Motion carries.

5. <u>Michigan Street Crossing Enhancement</u>

Mr. Miller shared the median recently installed on Michigan Street (at DeVos Place) elected not to add a rapid flashing beacon as was installed on the west side (adjacent to Bridgewater Place). As these two crossing options were evaluated for performance, it has been determined that two Rapid Flashing Beacons should be installed on the east side to further improve the ease and safety of pedestrian crossing. Mr. Miller stated with the size of this project being small and the erratic prices of material and labor, the request includes a contingency. Mayor Bliss shared feedback that many do not realize there is a crosswalk as they are driving over the bridge and asked if we could add signage as a warning that a crosswalk is coming. Mr. Miller stated this is part of the discussion; currently a DNN subcommittee is evaluating vehicle speeds, aggressive driving, distracted driving, and how this crosswalk is being used.

Motion: Mr. Avila, supported by Mayor Bliss, moved to authorize funding in an amount not to exceed \$35,000 for the installation of Rapid Flashing Beacons at the Michigan Street Crossing.

6. Hill and River Network Design Services

Mr. Miller presented the Hill and River Network project details (formerly known as Switchback Park) which includes east-west connections to the Grand River, the implementation of Switchback Park on Belknap Hill, the Hastings connector, improved connections at Newberry and Fairbanks, enhanced pedestrian crossings at Division Avenue, the pedestrianization of the railway tunnel connection under I-196, and the design and repurposing of the Ionia Avenue right-of-way. A steering committee to select the firm to provide design services included members of the City of GR, Neighbors of Belknap Lookout, and the Monroe North Business Association. 9 proposals were received, and 4 firms were interviewed before The Smith Group (one of the largest AE firms in the country) was selected to provide professional services for Phase 1 and Phase 2 of this work. The Smith Group, located in Ann Arbor, teamed with Fishbeck and Disability Advocates of Kent County as well as a geotechnical firm to evaluate the hill in more detail. This series of projects will be implemented incrementally over the years starting this month; this project was budgeted in FY22 under Public Realm Improvements. Mayor Bliss stated much of this property is owned by MDOT, not just the City. Mr. Miller agreed survey work will be an important and immediate step to determine the stakeholders and boundaries; The Smith Group does have experience working with MDOT and will be included in an early focus group. Mr. Avila asked the total cost of the project; Phase 3 work is estimated at \$300,000 to get at bidding with \$8-12 million estimated as the cost of the entire project. It was asked who will own the park at the end of the project; a Maintenance and Operations plan will need to be included in this work to determine what, when, and how we build.

Motion: Mayor Rosalynn Bliss, supported by Ms. Dunn, moved to authorize the Executive Director to enter into a professional services contract with The Smith Group, for an amount not to exceed \$516,630.

7. <u>Downtown Liquor License Request: Woodrow's</u>

Mr. Kelly shared Woodrow's GR is a proposed concept at the Amway Grand Plaza Hotel offering a full-service bar as well as 7 duckpin bowling lanes. With the consent of the DDA, this request will go to the city commission for approval. Staff believes this will be a great addition to downtown. Mr. Winn added the design team for Lyon Square is being consulted to ensure this is a complimentary space.

Motion: Mr. McNeilly, supported by Mr. Avila, moved approval of the resolution supporting issuance of a Downtown Development District liquor license for Woodrows GR, LLC at 187 Monroe Ave NW. Mr. Winn abstained. No one opposed. Motion passed.

8. World of Winter Funding Request

Ms. Van Driel presented 10 art installations recommended by the Goal 5 Alliance for World of Winter 2022. The success of WOW last year with the IDA Pinnacle Award brought 30 proposal submissions and the installations being recommended represent a variety of public art and placemaking opportunities. These include Bunnies of Intrude by Parer Studios (illuminated inflatable rabbits). Trumpet Flowers (interactive drums) and Crank Zappa (recycled trash-talking jellyfish) both by Amigo & Amiga, Light Maze by Brut Delux & Ilmex, Loop (motion picture music box) by CREOS, Control No Control (interactive LED touch cube) by Iregular, digital LED touch screens, Seasonal Wonders Projection Show by Live Space, Massimals Polar Bears by Jason Scroggin, and The Wave (suspended orbs) by Squid Soup. In addition will be bringing back the Singing Tree by Limbic Media as well as local artist installations. Mr. Winn stated adding art to the city each year would be ideal and asked if any of these could become permanent installations. Ms. Van Driel stated most are traveling installations but could look into purchasing some. Mr. Eddie asked if the Van Andel alley will be a location. Ms. Van Driel stated Studio Park will be a location for local artists, but art will be spread all around the city. Mayor Bliss suggested considering a larger marketing campaign such as Pure Michigan for these 3 months. Mr. Talen added Experience GR would be a good marketing partner and indicated his interest in funding this project well into the future.

Motion: Ms. Dunn, supported by Mayor Bliss, moved approval to fund 2022 World of Winter Art Installations in an amount not to exceed \$450,000. Motion passed unanimously.

9. Heartside Historic Murals

Ms. Van Driel introduced Jen Schaub with Dwelling Place to share the Heartside Historic Murals project. The Heartside Quality of Life study identified the need to educate the community on local historical figures and this project involves 32 different neighbors and artists. Artists were paired with locations and provided historical stories, events or themes to share. Jasmine Bruce, artist at 101 Sheldon, will depict immigration and the variety of people that have come to our city through the Union Depot. Kimberly Kunze with the LGBTQ+ Healthcare Consortium is creating a piece at the 40 South Division focused on the AIDS resource center and AIDS crisis in Michigan. Dustin Hunt will represent Ella Mary Sims (an advocate for African Americans and the poor) at 21 Weston. The long wall representing the history of impact of her life includes words her family uses to describe her. Ms. Van Driel added this will be part of the Women's Way program as well. Ijania Cortez, from Detroit, illustrated (3 activists that created) The Black Peoples Free Store at 235 S Division. Edwin Anderson is representing Black Joy at 359 S Division featuring The Horseshoe Bar and the Crispus Attucks Post traditional musical soul venue. These are all complete or will be completed in the next few weeks and ready for walking tours starting October 1 with a digital tour available in November.

10. <u>Executive Director Report</u>

Mr. Kelly highlighted the bicentennial commemoration of the 1821 Treaty of Chicago at Ah-Nab-Awen Park with the Grand River Bands of Ottawa Indians. He shared we recorded an increase of 2% in pedestrian traffic last month. The city is starting engagement on 6th St and Canal Park improvement projects. Upcoming events include Blues on the Grand, Moves on the Grand, Fiesta Mexicana, Mayor's Grand River Cleanup, ArtPrize, Confluence and Global Water Festival. We continue to showcase our Women's Way murals with the last ribbon cutting on the 29th.

SUBJECT: Resolution Approving and Recommending Amendment to the DDA District for

Spectrum Health System Center for Transformation and Innovation (CTI)

Attached is a resolution consenting to the removal of a parcel from the Downtown Development Authority's boundary. Removal of the parcel will facilitate approval of a Brownfield Plan Amendment submitted by Spectrum Health System (Spectrum) for their Center for Transformation and Innovation (CTI) in the North Monroe neighborhood of Downtown.

Spectrum Health Systems Overview

Spectrum is an integrated health system formed in 1997, and is the largest employer in West Michigan with numerous facilities throughout the region. Spectrum's health system includes the full array of general and specialized services and programs for individual health. Many of Spectrum's facilities are located in and around downtown Grand Rapids and include a large presence on the Medical Mile, including Helen DeVos Children's Hospital, Lemmen-Holton Cancer Pavilion, Fred and Lena Meijer Heart Center, Butterworth Hospital, and numerous ambulatory facilities and offices. Spectrum's investment in the Medical Mile in the past 15 years has exceeded \$1 billion. In addition, Spectrum has various office and service locations that it leases in and around Grand Rapids. Spectrum Health System currently employs approximately 31,000 individuals in a broad array of medical and non-medical fields. Approximately 5,500 of Spectrum's employees are residents of the City of Grand Rapids, and approximately 15,000 work in Grand Rapids on a regular basis.

Center for Transformation and Innovation

The CTI project proposed by Spectrum will create a system wide headquarters in the North Monroe district and will consolidate approximately 15 facilities located in Grand Rapids, and three facilities that are outside of Grand Rapids. These facilities currently house many non-patient facing operations including the following business units: medical group operations, finance, quality/safety, human resources, and risk & compliance.



Development of the CTI campus includes modernization of the existing 155,000 square foot Brassworks building and construction of a new 8-story, 157,000 square foot building, 680 ramped parking spaces, and approximately 215 surface parking spaces, all integrated into a combined campus. Spectrum's goals for the project align with its mission to "improve health, inspire hope and save lives" by developing a project designed around its flexible, productive and collaborative workplace strategy that will provide opportunities for clinical growth in a campus that can grow with the health care system and ultimately reduce operating and administrative costs. The strategic decision to locate in North Monroe also provides opportunities for Spectrum to continue and enhance its work in education, innovation and health improvement collaborations by strengthening its connections to leaders, experts innovators, and caregivers in West Michigan, many of which are located in Downtown.

The City of Grand Rapids and the Downtown Development Authority (DDA) have been working closely with Spectrum for approximately 18 months to ensure this significant investment and associated economic and health care benefits comes to fruition in downtown Grand Rapids. Spectrum's CTI will have space for 1,800 full-time employees at completion of the new 8-story building. Approximately 350 of these jobs will be new to the City of Grand Rapids. Currently, approximately 800 full-time employees work at home due to the COVID-19 pandemic work restrictions. Upon completion of CTI, Spectrum anticipates that all 800 full-time employees will return to the CTI Campus. Furthermore, CTI will also have dedicated training and event space on the first floor of the newly constructed building that will accommodate up to 500 individuals at a time. Spectrum continues to grow to meet the health care needs of the community and expects to continue bringing new jobs to the City of Grand Rapids through the CTI campus and future development in the area.

Development of the project has commenced with demolition of the former manufacturing facility located at 706 Bond Ave NW and renovation of the existing Brassworks building. Vertical construction of the new buildings will commence in Fall 2021 and the project is expected to be complete in Spring 2023. Total project costs are approximately \$100 million which include approximately \$90 million in hard construction, public infrastructure and professional services costs, and \$10 million in personal property investment. The Brownfield Plan Amendment would reimburse approximately \$22 million of eligible costs expected to be incurred by Spectrum for environmental activities, demolition, lead and asbestos abatement, site preparation and public and private infrastructure improvements, including the parking ramp.

In addition to recommending the Brownfield Plan, the City and DDA are also being asked to support the project by working with Spectrum to ensure infrastructure in the area will support both Spectrum's project and future investments in North Monroe, including long-term partnerships on quality of life investments that will benefit residents, visitors, employees and businesses in and around downtown. As part of the CTI build out approximately \$1.65 million of infrastructure improvements will be completed, including to Ottawa Avenue from Hastings to Trowbridge, and traffic signals at Division and Newberry. Funding for those projects was accounted for during the FY22 budgeting process, and requests to the City and DDA for the required work will come at future meetings. Additional improvements are planned on Ottawa Avenue north of the CTI and at the Coldbrook/Monroe/Ottawa intersection (converting from signalized intersection to a roundabout) in

future phases leveraging additional City and federal investments of approximately \$5 million. Spectrum is also engaged in planning initiatives for the Hill and River Network, as well as for 6th Street and Canal Parks.

Beyond infrastructure improvements, Spectrum is also dedicated to working with existing businesses and neighbors and has been meeting regularly with the Monroe North Business Association and the Neighbors of Belknap Lookout. Further, Spectrum has affirmed their commitment to equity, diversity and inclusion as evidenced in the Inclusion Plan submitted with their Brownfield application. Through various outreach, information and contract segmentation efforts, Spectrum has targeted \$4.0 million in participation by Minority-owned Businesses (MBE), \$1.6 million by Women-owned Businesses (WBE) and \$1.5 million by Micro-local Business Enterprises (MLBE). Overall, Spectrum anticipates \$7.1 million of the project to be contracted to MBE, WBE and/or MLBE subcontractors.

Summary of Requested Action

The project described above will take place on the properties currently identified as 635, 706 and 725 Bond Ave NW (new CTI building and parking), and 648 Monroe Ave NW (modernized Brassworks building). To facilitate the project and to receive reimbursement for eligible activities, Spectrum has applied to the City of Grand Rapids for a Brownfield Plan Amendment approval. Due to the Smart Zone and DDA already being established and in a position to capture property tax increment in this area, several properties need to be removed from the DDA and Smart Zone boundaries to allow the Brownfield Authority to support the project.

The following is a summary of the actions required by the City and DDA to approve this request:

- Removal of a portion of 710 Monroe Ave NW from the SmartZone and Downtown Development Authority's tax capture district;
 - Note as the SmartZone was established in this area in 2001, and before the DDA expansion in 2016, the DDA does not currently capture tax increment revenue from 710 Monroe Avenue.
- Removal of 635, 706 and 725 Bond Ave NW from the SmartZone Local Development Finance Authority's certified technology park district;
- Brownfield Authority approval of a Plan Amendment; and
- Public hearings and adoption of the Smart Zone and DDA Plan Amendments as well as the Brownfield Plan Amendment by the Grand Rapids City Commission.

At their meeting on October 7, 2021 the SmartZone approved a resolution removing the requested properties from their district. If the DDA approves the attached resolution the next step would be Brownfield Authority's consideration of the Plan Amendment on October 28, 2021.

Recommendation: Approve the resolution recommending revisions to the City of Grand Rapids Downtown Development Authority boundary to support approval of a Brownfield Plan Amendment for Spectrum Health's Center for Transformation and Innovation.





Key Dates

March 10, 2020 - Michigan confirms its first two COVID cases; State of Emergency declared

March 13, 2020 - Gov. Whitmer closes all K-12 schools; bans gatherings of 250 or more March 15, 2020 - Gov. Whitmer orders the closure of bars/restaurants for dine-in, gyms, theaters, and other public places

March 24, 2020 - statewide stay-at-home order begins (subsequently extended 4 times)

April 13, 2020 - first round of stimulus payments begins

June 19, 2020 - stay-at-home order expires

September 9, 2020 - gyms, pools, and organized sports are allowed to reopen/resume October 9, 2020 - movie theaters, performance venues, arcades, and other businesses can reopen at limited capacity

November 15, 2020 - Gov. Whitmer orders the closure of high schools and universities, as well as other businesses (extended on December 7, 2020)

December 18, 2020 - partial shutdown extended but allows for some businesses like theaters, casinos, and bowling alleys to reopen at limited capacity

December 18, 2020 - first COVID vaccine administered in Kent County

December 29, 2020 - second round of stimulus payments begins

February 1, 2021 - indoor dining reopens with 25% capacity, curfew, and other requirements

March 5, 2021 - restaurants reopen to 50%, other business capacity augmentations

 $March\,31,\,2021\,$ - all population groups eligible for the COVID vaccine in MI

May 10, 2021 - Michigan hits milestone of 55% first-dose vaccinations

May 24, 2021 - all in-person work can resume

June 1, 2021 - outdoor capacity limits end, full capacity allowed at outdoor sports and entertainment venues, indoor capacity for many businesses increases to 50%, curfew ends, table limits and social distancing between tables ends

June 22, 2021 - Michigan lifts capacity limits, mask restrictions

August 1, 2021 - Kent County risk level moves to 'moderate'

August 13, 2021 - Kent County risk level moves to 'substanial'

August 17, 2021 - GRPS requires masks indoors

August 20, 2021 - Kent County risk level moves to 'high'

August 23, 2021 - FDA fully approves Pfizer vaccine














Our team focused on some big ticket items prior to thousands of pedestrians descending onto our sidewalks. Some of our main focuses were weeds, graffiti and pressure washing.


