Board of Advisors Meeting

February 12, 2018

1. <u>Call to Order</u> – The meeting was called to order at 3:31pm by Kayem Dunn

2. <u>Attendance:</u>

3. Approve Minutes from November 2, 2017 DGRI Board Meeting

Motion: Brian Harris, supported by Mayor Rosalynn Bliss, moved approval of the November 2, 2017 meeting minutes as presented. Motion carried unanimously.

4. <u>Board Appointments</u>

Mr. Kelly took a moment to introduce each of the new members of the Board and how their organizations and expertise will continue to be vital in the implementation of the GR Forward Plan.

Motion: Nick Monoyios, supported by Rosalynn Bliss, moved to appoint Eddie Tadlock, Monica Steimle-App, Jorge Gonzales, Shaun Biel, and Wayman Britt to the Downtown Grand Rapids Board of Advisors as called for in the DGRI bylaws and recommended by the DGRI Executive Committee. Motion carried unanimously.

5. Election of Officers

Ms. Dunn shared that there is a 2-year term limit for the DGRI Board of Advisors Chair and Vice-Chair and that there is a need to elect new officers. Mr. Harris nominated Nick Monoyios as Chair and Kayem Dunn as Vice-Chair of the DGRI Board of Advisors. Mr. Kelly noted that this would also mean that both Mr. Monoyios and Ms. Dunn would serve of the Executive Committee.

Motion: Brian Harris, supported by Raymond Kisor, moved to approve the appointment of Nick Monoyios as DGRI Board of Advisors Chair and Kayem Dunn as DGRI Board of Advisors Vice-Chair. Motion carried unanimously.

Mr. Monoyios thanked the Board for the confidence and said he looks forward to working with Mr. Kelly to lead this group.

7. Report from the Exploration Committee

Ms. Dunn shared that Mr. Harris and herself have led the exploration committee for identifying the needs of the organization as well as a new President & CEO of DGRI. Ms. Dunn thanked the various board members for their participation and gave a brief overview of how the committee has proceeded over the past few months in light of Mr. Larson's departure. Ms. Dunn said it was imperative to understand where the needs of the community are now and how they have evolved since the creation of this organization. Ms. Dunn said it was clear, and the Executive Committee has agreed, that Mr. Kelly should be named President and CEO of DGRI. Ms. Dunn said should it be approved at this meeting, it will need to receive final approval from City Commission. Mayor Bliss said she is excited to support this recommendation and knows that Mr. Kelly will serve as a strong leader for the organization. Mr. Harris said this choice was not a matter of convenience but Mr. Kelly presented himself as the best candidate with the skills to match the task at hand. Mr. Kelly said he is humbled by the vote of confidence from this Board and is excited to lead the organization and see GR Forward implemented.

Motion: Brian Harris, supported by Jon Nunn moved to accept the Exploration Committee's recommendation to appoint Tim Kelly DGRI President & CEO. Motion carried unanimously.

8. <u>Presentation on River Restoration and River Design Guidelines</u>

Mr. Kelly introduced Mr. Bishop from Grand Rapids White Water, Mr. Bosworth and Ms. Wells from the consultant team working on the River Design Guidelines, to give presentations and updates from the effort to restore the rapids and create a new rivertrail design. Mr. Bishop gave an overview of the timeline for the in-water work for the restoration of the rapids. Mr. Bishop shared the plans for the adjustable hydraulic structure as well as a proposed governance structure for the management of lamprey control. Mr. Bishop said there is a current MOU being finalized to ensure that the adjustable hydraulic system is managed properly before construction begins. Mr. Bishop said final permits for the environmental

conservation plan are also being finalized due to the sea lamprey and snuffbox mussel. Mr. Bishop gave an overview of the current pledged funds as well as the plans for a capital funding campaign. Mr. Bishop thanked the City for their partnership in seeing that this project is a priority and momentum is continuing. Mr. Eddie asked about the functionality of the hydraulic dam in the winter months. Mr. Bishop said the other systems that have been studied, operate in similar climates, so the weather should not be an issue. Mr. Kelly thanked Mr. Bishop for his presentation on the restoration of the rapids.

Mr. Bosworth introduced himself to the Board and shared that he and Ms. Wells are consultants on the river trail design guideline process. Ms. Wells, from Williams and Works, said the focus of the engagement process has been to understand how people interact with and use the river. Ms. Wells said the consultant team is hoping to use these engagement opportunities to begin identifying what materials to use and what amenities may be a priority moving forward. Ms. Wells gave an overview of the information that was gathered from the feedback sessions. Mr. Bosworth gave an overview of the five (5) various opportunity sites and the design plans. Ms. Dunn asked if the outcome of this process is a set of guidelines or designs for park sites. Ms. Wells said both. Ms. Wells said there will be concept designs for the opportunity sites as well as a set of guidelines for future development that may happen along the river. Mr. Bosworth added that there is also an asset management component that will outline who is responsible for maintaining the riverwalk. Mayor Bliss asked if there have been any conversations with Consumers Energy about making the transformer site more attractive. Mr. Bosworth said he is unaware of any plan to relocate or mask the transformer. Mr. Monoyios asked if there is an opportunity for development on certain sites to increase the tax base. Mr. Bosworth said there are limits on some of the sites because of the process for acquiring the land utilized the Natural Resource Trust Fund. Ms. Dunn said she believes this should be looked into because it will be important to have a buffer between the highway and a public space. Mr. Harris said he would like to have more clarity on how this disposition of land is occurring and what the limitations of use may be before finalizing design plans. Mr. Monoyios said he would also like to see operational sustainability before these plans move too far along. Mr. Kelly said we can continue to receive updates so that the Board has more clarity on funding and operational plans moving forward. Mr. Monoyios thanked everyone for their presentations.

9. Chair's Report

Mr. Monoyios said he is excited about the new structure of the Alliances and the new chairs that it has brought to this Board. Mr. Monoyios said as the complexities of GR Forward unfold the spirit of collaboration will continue to be imperative. Mr. Monoyios said historically this Board has met quarterly, but there may be an opportunity to transition to bi-monthly. Mr. Monoyios said he would follow up to help identify if there would be value in an increased schedule. Mr. Harris said he believes it would be beneficial to have a brief overview of the GR Forward goals and how the various Board members play a role in that implementation at a future meeting. Mr. Harris said the purpose of this body was to create alignment among organizations and wants to ensure that that alignment is plan implementation focused. Mr.

Harris said more frequent meetings may not add value if there is not a clear definition of tasks and mission. Mr. Monoyios said he would work with staff to determine if more meetings will be scheduled moving forward.

10. <u>Board of Advisors Discussion</u>

Mr. Monoyios took a moment to recognize Mr. Kisor as the founding chair of DGRI. Mr. Kelly said this is Mr. Kisor's last Board meeting and wanted to recognize the crucial part he has played not only in the founding of this organization, but in the city as a whole. Mr. Kisor thanked the Board for the opportunity to serve and said he is looking forward to seeing the progress this organization will make in coming years.

SUBJECT: GR Forward Implementation Update

On a quarterly basis, DGRI does a report out of progress being made toward priorities identified in GR Forward. Attached for your review is an overview of progress made through Q1 2018. Among the highlights are:

- Completion of Lyon Square Design Development documents. Funding was approved by the DDA to complete Construction Documents.
- Initiation of construction at Ah-Nab-Awen / Indian Mounds. Improvements include flood protection enhancements, improved bandwidth with a 15-foot trail section, enhanced public seating and new lighting from Pearl Street to Gillett Bridge.
- Facilitated process (ongoing) with Downtown residents to define the purpose and structure for a resident organization.
- Surveyed Downtown residents for their ideas and perspectives on a variety of issues to inform resident organization priorities.
- Completed feasibility study of bike share for Grand Rapids. Recommendations for implementation coming in summer 2018.
- Issued RFP for Retail Business Recruitment and Incubation Program. The program will make funding available to ease entry into Downtown for retailers.
- Designed and approved short-term activation tactics for Summer 2018 on Calder Plaza. Elements will
 include furniture, shade umbrellas and various entertainment options.

Q2 implementation priorities include installation of a protected bike lane on Division Avenue, completion of additional Downtown murals, completing a realignment and rebranding of the DASH service and finalizing design guidelines and conceptual plans for the Grand River trail and River adjacent public spaces. Progress on these, and other organization goals will be reported in Summer 2018.

GR>> IMPLEMENTATION UPDATE Q1 2018

Goal 1 - Reestablish the Grand River as the draw to the City and Region

Action: Develop riverfront trail design guidelines

- Lead: City of Grand Rapids. Wenk Associates serves as lead consultant
- Project involves defining a "playbook" to guide construction of the proposed recreation trail on the banks of the Grand River. This includes:
 - o Establishing an overall character and identity for the trail
 - o Defining unique themes and amenities at different points along the trail
 - o Ensuring improvements along the river edges are integrated with and support whitewater rapids restoration
- Community outreach and ideation underway, including a presentation of draft concepts to *GR Forward* Goal 1 Alliance and DGRI Board of Advisors.
- Recommendations coming in Spring 2018

Action: Restore the whitewater rapids in the Grand River

- Lead: Grand Rapids Whitewater
- GRWW organizing to file in Summer 2018 for state permits and initiate environmental review of the river restoration project

Action: Evaluate economic impact of improving and expanding the riverfront trail

- Lead: Downtown Grand Rapids Inc.
- Contracted Grand Valley State University to conduct analysis
- Preliminary findings anticipated in Summer 2018

Action: Enhance Lyon Square Opportunity Site

- Lead: Downtown Grand Rapids Inc. and City of Grand Rapids
- Design Development documents complete. Funding approved by the DDA to complete Construction Documents.
- Coordination with surrounding stakeholders in process

Action: Enhance Ah-Nab-Awen / Indian Mounds Park

- Construction anticipated to begin Spring 2018

GR Forward Goal 3 - Implement a 21st century mobility strategy

Action: Deploy bus shelters to enhance experience for people who ride public transit

- Mobile GR presented bus shelter deployment plan to City Commission on Feb. 6, 2018.
- GR DDA budgeted \$500,000 to support Downtown deployment
- Goal is to deploy new Downtown shelters before next winter.

- Specific improvements for evaluation include but are not limited to the installation of pedestrian medians, changes to crosswalks, pedestrian county-down signals and a pedestrian scramble.
- The project also includes piloting a designated bike lane along Division Avenue.

I. Key Indicators

Why this matters: DGRI adopted a set of 15 indicators (Exhibit A) intended to help inform the overall performance and health of Downtown. While some of these items are outside of DGRI's direct control, they do help to indicate the direction that the community is moving relative to various ambitions associated with the economic, social, and environmental wellbeing of Downtown. The 15 indicators reflect respective priorities of the DDA, the DID, and the MNTIFA and were also informed by GR Forward and other community planning efforts such as Green Grand Rapids.

Objective 1: Finalize methodology, et al, for all performance measures (see Exhibit A), prepare an overview to be delivered to the DGRI Board of Advisors.

Objective 2: Develop analytic dashboard using available data to articulate the direction and progress of Downtown. Present said dashboard at 2017 State of Downtown Event.

Objective 3: Working with DGRI Board of Advisors, establish performance targets for FY18 and an implementation approach designed to reach them.

II. GR Forward Project Implementation

Why this matters: While completing the GR Forward Plan was important, ushering in that future will involve hundreds of smaller capital projects, programs, and policies. The more that DGRI and its partners collectively deliver on the promises made in the Plan, the more the community grows confident in the Plan's ability to continually inspire and align.

Key Objectives:

- 1. Plant 200 trees in Downtown
- 2. Complete the Coldbrook Edge Project
- 3. Redesign Calder Plaza

- 4. Enhance 131 Overpass conditions
- 5. Reboot the DASH system
- 6. Establish Downtown Residents Network
- 7. Complete Bikeshare feasibility study

III. Leadership and Advocacy:

Why this matters: DGRI is uniquely positioned to harness the power of partnerships to achieve community goals and inspire a best-in-class approach to city building. Accomplishing specific, targeted advocacy endeavors will expand on the organization's credibility as a can-and-will do agent for change and progress.

Key Internal Policy Objectives:

- 1. Amend private development support tools to reflect the priorities from GR Forward.
- 2. Amend DDA TIF and Development Plan to eliminate special millage capture.

Key Local Advocacy Objectives:

- Lead effort to introduce new citywide food truck ordinance and mobilize support to ensure its approval.
- 2. Work with the Planning Department and Grand Rapids Planning Commission to amend Downtown zoning to reflect height and land use restrictions recommended by GR Forward.
- 3. Advance projects and initiatives that improve the status of community relations within Grand Rapids, particularly those that involve social equity.

Key State Level Advocacy Objectives:

- 1. Continue efforts to build and mobilize a coalition to support good legislative TIF reforms.
- 2. Identify state lawmakers to introduce modifications to the State property tax legislation that would enable owner-occupied residential property to be assessed by the DID.
- 3. As needed, develop collaborative strategies to effectively inform appropriate state officials about Grand Rapids' urban policy / investment priorities.
