

CWU's housing and stabilization programs served 509 families in fiscal year 2012. These programs include emergency shelter for homeless families and supportive housing services for formerly homeless families living in permanent housing. CWU is one of the largest providers of emergency shelter in Massachusetts, operating 117 units. Our housing and stabilization programs provide intensive education and case management to help families stabilize and gain the skills and confidence necessary to achieve economic independence.

CWU's GED program offers an alternative to a traditional school setting, providing young adults with the individual attention and supportive services they need to succeed. The fulltime program's holistic approach focuses equally on academics, support, and preparation for an economically self-sufficient future. The no-cost GED program provides free transportation and free lunch to students. In fiscal year 2012, CWU's GED program served 70 students, of which 38 students passed at least one test towards their GED and 18 students attained their GED.

Career Family Opportunity (CFO) is CWU's groundbreaking pilot program that helps single parents achieve economic independence. This pioneering five-year initiative allows program participants to create personalized plans that will lead to a stable future for themselves and their families. At the end of this program, the goal is for participants to have attained a job that pays a family-sustaining wage and have \$10,000 in savings. In fiscal year 2012, CWU served 45 families in its CFO program. The average wage increase for the initial group of participants in the program was 36% and 92% of these participants were enrolled in an education program.
