Escambia County Tax Collector Janet Holley Recognized for Audit Report

One of 11 Tax Collectors Recognized for Audit Report

Tallahassee – Janet Holley, Tax Collector for Escambia County, received a special recognition by the Florida Tax Collector's Association (FTCA) for earning a clean financial audit.

Holley was presented with the Certificate of Merit by FTCA President Doris Maloy, of Leon County.
