About the Office

Janet Holley, as tax collector, is responsible for the collection and distribution of a variety of taxes and fees. She is a constitutional officer and a fee officer; her office is funded by the fees earned for services provided. The tax collector's office has a cash flow of \$600 million. She collects taxes for the District School Board, Board of County Commissioners, City of Pensacola, Town of Century, Sheriff, Downtown Improvement Board, Northwest Florida Water Management District, Department of Highway Safety and Motor Vehicles, Florida Fish and Wildlife Commission, and Department of Revenue.

The tax collector's office issues driver licenses and identification cards, registrations and titles for vehicles and vessels, sells hunting and fishing licenses and business tax receipts, collects real estate and tangible personal property taxes, and issues Going Out of Business Permits.

With an annual budget of \$7 million, Janet Holley operates four offices with a staff of 100 full-time employees.

Office Innovations

Under Ms. Holley's tenure:

- The office has been streamlined to offer a one-stop concept. Each tax agent handles all services.
- Relocation and expansion of branch offices that offer the convenience of drive thru, after hours drop box, and improved parking.
- Took over driver license and ID card services from the State.
- Introduced fast title service.
- Implemented an appointment system, including online access.
- Expanded payment options by being the first tax collector in the state to offer payments by both debit and credit card and electronic check. Initiated payments by phone, in person, and online.
- Created a *Peace of Mind* program to help property owners remember to pay their taxes.
- Implemented a web site to provide information, statistics, electronic communication, and payment options for ease of access to public information 24 hours a day.
- Implemented an online tax certificate sale to reduce costs and promote greater access.
- Improved customer feedback by being responsive to comment cards.
- Created a call center to better serve citizens over the phone.
- Created community awareness program for GetRealID.com.
- Implemented the Kids Tag Art Program in Escambia County to inspire fifth graders to design their own specialty plates as a learning tool for the students and to raise funds for the participating schools' art programs.
