* These precincts are partly within the city limits and partly in the county; only those voters residing within the city limits of Pensacola are eligible to vote in city elections.

** All of precinct 15 is located within the city limits. Persons who are registered voters in the precinct in which the county courthouse is located, precinct 15, and who are residing outside the county with no permanent address in the county, shall not be registered electors of a municipality, and shall not be permitted to vote in any municipal election; F. S. 101.045(1).

The Mayor and two members of the Council are elected at-large; they represent the entire city. All eligible voters residing within the city limits of Pensacola may vote on the Members of the City Council representing their district as well as the Mayor and at-large districts.
