

LAFAYETTE COMMUNITY SKATE PARK SAFETY AND CONDUCT RULES

SKATE AT YOUR OWN RISK

1. A helmet is required (fastened). Other safety equipment is recommended.
2. All skaters must have a signed liability waiver on file with The Lafayette Community Skate Park. Participants under the age of 18 must have a parent or legal guardian sign the waiver.
3. All persons must speak and act respectfully. No swearing or rude language. Fighting, profanity or any other disruptive behavior is strictly prohibited. Faith Community Center (FCC) staff, Faith Baptist Church (FBC) staff and members have the discretion to identify unwarranted conduct as necessary to ensure that participants and attendees have an enjoyable park experience.
4. No motorized vehicles allowed.
5. No tobacco products, illegal drugs, or alcohol is permitted.
6. Examine the surface carefully for debris, surface irregularities or other damage before each use.
7. By using this facility/equipment, you acknowledge that there are risks and hazards involved in or arising from use of the or presence upon these skateboarding facilities and you assume any and all risks involved in or arising from use or presence upon the facilities, including the risk of stationary objects, and the negligent or deliberate act of another person(s).
8. No food, drink or chewing gum may be brought into the skating area.
9. Gear and clothing not in use must be stored outside of the skate area. Non-skate related gear is not allowed in the skating area. Shirts and shoes must be worn at all times.
10. Other than for special events sanctioned by the Lafayette Community Skate Park, contests or other competitions are prohibited.
11. The Lafayette Community Skate Park reserves the right to cancel any membership at any time or eject anyone for any reason.
12. Skaters are responsible for arranging for their own pick-up and/or transportation from Lafayette Community Skate Park property.

THIS AGREEMENT RELATES TO FAITH COMMUNITY MINISTRIES, LLC and THE LAFAYETTE COMMUNITY SKATE PARK, located at 5572 Mercy Way (5526 St Rd. 26 E.) Lafayette, IN 47905

THIS AGREEMENT CONSTITUTES AN EXPRESS CONTRACTUAL ASSUMPTION OF ALL RISKS, WAIVER OF AND RELEASE FROM ALL LIABILITY, INCLUDING BUT NOT LIMITED TO NEGLIGENCE, AND AN INDEMNITY FOR ALL THIRD PARTY CLAIMS.

We know that skateboarding, in-line skating, bicycling, and other forms of skating are inherently dangerous sports and activities in which we choose to voluntarily participate at our own risk. We are aware that the usual risks, hazards and dangers of personal injury, death and disability or property damage and loss (collectively "damages"), necessarily increase when using ramps, curbs, steps, half pipes, inclines or declines, bowls or any other structure and device. We know that the risks, hazards and dangers include, but are not limited to, uncontrollable boards, falling, jumping, landing, performing tricks, colliding with other users, staff, media personnel and spectators. We also understand that these risks, hazards and dangers are further increased when other persons, whether or not of the same level of experience or skill, are present at the same time and are using the same facilities. (All of the above defined activities are collectively referred to throughout this Agreement as "Hazardous Activities".)

We have read, understand and agree to be bound by the Rules of Safety/Conduct governing my behavior while using the Park. We understand that these rules are strictly enforced.

The undersigned further certifies that he/she has no medical condition, which would cause participation in activities at the Park to be potentially hazardous to his or her health. In addition, this Agreement shall constitute authorization for the Park to provide or cause to be provided such medical treatment to the undersigned as may be necessary or appropriate if any injury occurs while at the Park. I further authorize attending medical personnel to execute on my behalf any permission forms, consents, or other appropriate documents relating to medical attention and to act on my behalf if I am not able or immediately available to do so.

The undersigned also authorizes The Lafayette Community Skate Park the right to use all photographs and/or video(s) taken of the participant while participating in activities at the Park for advertising or promotional purposes.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS AGREEMENT, and further agrees that no oral representations, statements, or inducements apart from this Agreement have been made by the Park or anyone else with regard to the subject matter of this Agreement.
