**Dr. Levy Class Action**

**JANE DOE No. 1, ET AL. V. JOHNS HOPKINS HOSPITAL, ET AL.  
CASE No. 24-C-13-001041  
IN THE CIRCUIT COURT FOR BALTIMORE CITY**

A mandatory, settlement class action has been certified in the Baltimore City Circuit Court on behalf of former patients of Nikita Levy, M.D. and possibly others. This action was conditionally certified as a mandatory, no opt out settlement class action by Order of the Court on October 30, 2013, pursuant to Maryland Rule 2-231 (b)(1)(B).

This action seeks to resolve all claims arising out of, based on, related to, or involving injuries and damages claimed as a result of Dr. Levy's alleged photographing or videotaping activities or boundary violations while he was an actual or apparent agent, servant, or employee of Johns Hopkins during the period from April 26, 1988 until February 8, 2013.

Establishment of this Class by the Court does not mean that any Class Member will receive any money. In the event the settlement negotiations produce a settlement, the Court will provide further notice of the settlement's terms and any related proceedings. If the settlement negotiations do not produce a settlement, the Court will provide you a further notice regarding future proceedings and how to protect any rights you may have.

If you believe that you are a member of this Class by being a former patient of Dr. Levy or were secretly videotaped, photographed, or suffered boundary violations by Dr. Levy during the period of April 26, 1988 until February 8, 2013, you should submit a Registration Form.
