We understand that you are the owner of the above named website. We write with reference to the content of that website, several statements of which are libelous to Atos Origin and Atos Healthcare, together "Atos".

We draw your attention to a few examples of libelous statements on the website viewed on 13 May 2011, copies of which are enclosed for your convenience:

- Home page: "Atos Kills!"
- Home page: "Atos Healthcare"
- Home page: "Please help After Atos keep a record of the abuse being carried against the sick and disabled by ATOS."
- Petition page: "Atos has treated the disabled disgracefully and is in breach of common human rights found in the European Bill of Human Rights, the United Nations Declaration fo Human Rights and the very rights of this country, the United Kingdom, Great Britain and Northern Ireland."

We note that Atos are easily identified on your website and note in particular that the use of "Atos Healthcare" across the website is a direct attack on Atos Healthcare. We also note that the statements described above directly state that Atos carries out its business illegally and/or in an abusive or detrimental manner. These statements are inaccurate and unsupportable and should be removed immediately.



We look forward to hearing your response at your earliest convenience and in any event no later than **14 days** from the date of this letter.



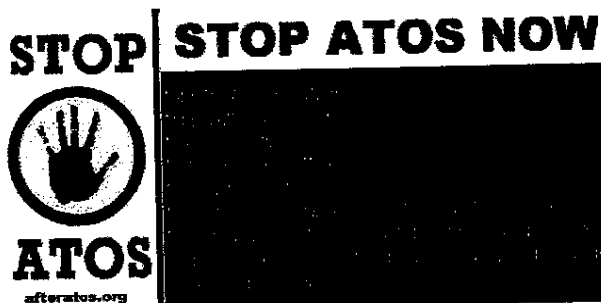

Stop Atos NOW Petition

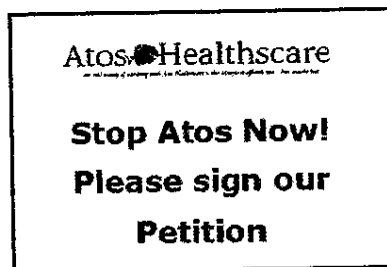


We demand that the Government immediately stop the Atos Esa Medical Assessments of disabled as it is causing much harm. Everyday severely disabled and chronically ill people are being put through unnecessary assessments, physical discomfort, mental trauma and being taken off all basic benefits for months. We demand that the government STOPS ATOS assessments NOW! Cancel the contracts as Atos has treated the disabled disgracefully and is in breach of common human rights found in the European Bill of Human Rights, the United Nations Declaration fo Human Rights and the very rights of this country, the United Kingdom, Great Britain and Northern Ireland. And it is contrary to every professional code of practice written in the General Medical Council and Nursing and Midwifery Councils right for a practitioner to registration and practice. We demand the that every disabled person who has gone through Atos Medical and DWP ESA process is accounted for – whether alive or dead. For many have found the last few days on earth made a misery and suffering when they most wanted peace and time with their families. We demand that the Government accounts for these people of this country who it is duty bound to protect and defend and support the law that does so.



We demand that in addressing the needs of disability and work the government returns to

reason and rational and the foundation of scientific and medical knowledge, the understanding and knowledge of nursing profession and more importantly than anything puts the disabled person's personal understanding and experience of his/her condition first. We the people of this country, the disabled and After Atos ask the government to account for its disabled citizens and let us know what happened to them. If not, and even so, After Atos will.
