# STEP 1: PRE-CAMP PROGRAM DETAILS

*(Create your own Parent Pack from Step 1 and Step 2 below)*

## WELCOME

We are so glad that you chose to come to FUGE Combo Camp this summer. We hope that this information packet will be helpful in your camp planning.

### WHAT IS COMBO CAMP?

Combo Camp is a chance for your students to all attend the same camp location (Mississippi College) but attend different camp programs (Centrifuge or M-Fuge) as you so choose. When you register for this week at Mississippi College you must determine how many students will be in each program, you cannot decide upon arrival at camp.

### WHAT DOES COMBO CAMP AT MISSISSIPPI COLLEGE LOOK LIKE? COMBO CAMP AT MISSISSIPPI COLLEGE INVOLVES: CENTRIFUGE AND M-FUGE.

- **Centrifuge** is for your students who want graded Bible studies with students from other churches, recreation, and afternoon track times, all facilitated by Fuge camp staff.
- **M-Fuge** is for your students who want to participate in Bible study and missions with students from other churches, led by Fuge camp staff.

## REGISTRATION POLICY AND PAYMENT SCHEDULE

**BEFORE FEBRUARY 1:** You may reserve your spot at camp anytime before February 1, 2009 with no deposit.

**FEBRUARY 1:** A \$50 per person deposit is required for each reservation to be paid on or before February 1. If you have already registered, you are required to pay a \$50 deposit per person to hold your reservation. Any new or additional reservations made after February 1 will require an immediate \$50 deposit per person. **ALL deposits are non-refundable and cannot be applied toward balance due.**

**MAY 1 - CANCELLATION DEADLINE:** All cancellations made after May 1 will incur an additional \$50.00 fee for each person dropped. **When cancellations occur, deposits cannot be applied toward balance due.**

**14 DAYS PRIOR TO CAMP:** Final balance must be received 14 days before your arrival at camp. If it is not, your group will be charged a one-time \$75.00 late fee.\*

**\*AUTO PAYMENT OPTION:** Authorized Group Leaders may give permission to charge the remaining balance to a church LifeWay account or credit card by calling LifeWay Events Registration at 1-877-CAMP-123. This must be done by May 1, 2009. Any adjustments for drops or additions will be applied to the specified account after camp.

## WHAT TO BRING

- Linens, towels, pillows, blankets
- Water bottle that you can refill and carry with you
- Closed toe, closed heel shoes (for outdoor activities)
- Bible, notepad, and pen
- Toiletries such as toothbrush and shampoo
- Sun protection
- Spending money for snacks, camp store, and missions offering (optional)
- DO NOT BRING alcohol, tobacco, illegal drugs, fireworks, water guns, or any kind of weapon
- DO NOT BRING radios, iPods, CD players, play station portables or other gaming devices, roller blades, skateboards – if students do bring cell phones please help be sure it is not a distraction at camp

### **SPECIAL NEEDS REQUESTS**

Fuge takes the special needs of students and adults seriously. Meeting your needs and setting up your group for a great week of camp is important to us.

If one of your students has a special need that should be handled before camp starts, please call our camp toll free line (1.877.CAMP.123) and share that with our events registration team so that it can be handled properly. The special need can also be shared with us via email to [fuge@lifeway.com](mailto:fuge@lifeway.com).

If your student's need should be known by our camp staff at camp, you have the option of completing a "Special Attention Card" for your student so that this need can be addressed by the Fuge staff. You can print and fill out this card before camp, or you can fill it out on registration day at camp. You can find a copy of the Fuge Special Attention Card in the Appendix of this document.

## NIGHT LIFE

Night Life at Fuge camps is a time for the whole camp to come together and get a little crazy. Each night has a different fellowship activity.

We don't want to ruin the surprise by telling you too much, but we will be having one Night Life where students and adults have the option of dressing up. The dress up night will have an athletic theme. Bring old gym uniforms, knee socks, sweatbands and anything else fun you can think of! You will have time to change into your dress up clothes before the Night Life begins that evening.

## DAMAGES

Please be aware that your group is personally responsible for damages to any facilities including but not limited to the dorm room your group occupies. You will also be asked by the facility to pay for any lost keys.

## DRESS CODE

Please ask your students and adult sponsors **NOT** to pack anything that:

- Advertises alcohol, tobacco, illegal drugs
- Explicitly or implicitly promotes racism, sexism, or hatred of any group or person
- Explicitly or implicitly refers to sexual actions or situations
- Has spaghetti straps, except for sleepwear
- Is excessively short or tight fitting.

While at camp, we ask that students and adults:

- Wear modest, one-piece bathing suits or two-piece suits covered with a colored t-shirt;
- Wear modest shorts, dresses, slacks, and jeans for worship. Long pants or knee-length skirts are required for students or adults participating in worship on stage;
- Do not dress in a way that calls attention to underwear (sagging your pants, rolling down your waistbands, etc);
- A dark t-shirt if you plan to take the messy games or water games track.

We invite you to join us as leaders in monitoring your group to ensure they are dressing appropriately.

## MISSIONS OFFERING

The summer of 2009 we will celebrate the 25th anniversary of the Fuge missions offering. Students have given more than 8 million dollars and last year alone students gave over \$611,000. This mission offering goes to support the work of both the International Mission Board (IMB) and the North American Mission Board (NAMB).

These agencies have allowed us to target specific ministries with which students can identify. Our offering going to the IMB will continue to support the work of missionaries working with the Romany people in Central and Eastern Europe. More than 350 students responded last summer by going with their youth groups to minister and multiply the hands and feet of the Roma missionaries.

Our offering going to NAMB will help to support their Current Canada summer missions program. Current Canada is a partnership project between the North American Mission Board and the Canadian National Baptist Convention. This program is open to students who have completed the 11th grade or higher. You can check out their website at [www.currentcanada.com](http://www.currentcanada.com).

You have the opportunity to pray, give, and go to help these people groups learn about the gospel. A missions offering will be collected at camp this summer, we hope you will begin praying now about what your church group can give.

## SPONSOR QUALIFICATIONS

- In order to provide the best atmosphere and supervision, we ask that all groups bring 1 male sponsor for every 5 boys, and 1 female sponsor for every 5 girls.
- All sponsors must be at least 21 years old.
- Help enforce curfew and supervise clean up of your groups' housing.
- Aid in monitoring the dress code of your students.
- Encourage participation and promptness by setting an example.
- If you have a college student coming with your group who is under age 21 that person cannot be counted as a sponsor. However, those college students do not have to be included in your student ratio – for example, if you bring 5 high school boys and 4 college-aged boys, you will only need 1 male sponsor since the 4 college-aged boys don't count in your sponsor to student ratio.

## BRINGING CHILDREN TO CAMP

We want you to be able to spend more time with the ones you love during your busy summer. Children too young to participate in our camp programming (completed 5th grade or younger) can join you at camp with the following parameters:

- Bed space and meals = full price
- No bed space or meals = no charge

We want your family to experience worship together, but not at the expense of everyone else. We ask that you please take your child out of the service if they are a distraction to others. Children must have adult supervision at all times. Please also consider the needs of your students and ensure enough adults accompany your group to build relationships and focus on their camp experience.

## **CHURCH GROUP AND PARENT DEVOTIONS**

Church Group Devotion is a time for each church group to be together in the evenings to debrief the day. This time usually lasts one hour. The Group Leader needs to determine what should be discussed or taught. The Fuge office provides devotions for this time which can be found on the Fuge website after April 1. Print this and bring it to camp with you, if you choose to use it.

Parent Devotions are also available on the Fuge website after April 1. This resource is for you to give parents so that they can follow along and know what your students are learning in Bible study.

## **AFTER CAMP BIBLE STUDY**

This year, Fuge is providing an After Camp Bible Study that is designed to follow the camp experience. You can use it as Sunday school curriculum or for your mid-week events. There are three sessions of this study and it can be found on the Fuge website beginning April 1.

## **TRANSPORTATION POLICY FOR M-FUGE**

Groups must provide adequate and appropriate transportation and drivers for students to get to ministry sites while attending M-Fuge.

The best way to ensure adequate transportation is for each group to provide enough seating, with seat belts, to cover the number of participants the group is bringing. The vehicles best suiting the needs for use at M-Fuge are minivans, personal vehicles, 12 passenger vans, and mini buses. If 15 passenger vans are brought for use by churches, according to LifeWay Christian Resources and many state laws, M-Fuge will not load more than 11 passengers (including driver) on them.

### **What about large / charter buses?**

M-Fuge will make the best possible use of large buses. While we welcome you to bring whatever source of transportation to camp that best suits the needs of your church, we must recognize that the use of large buses poses some significant logistical difficulty. If you bring a large bus to camp, we are asking that you make it available for use each day of ministry projects. Please keep in

mind that the driver is required to stay on ministry site and is not allowed to leave. You may also be asked to provide, rent if needed, additional transportation to stay on site in case of emergency. This additional transportation could include cars, mini-vans, or 12 passenger vans. Bringing a couple of additional personal vehicles to camp per large bus is suggested for churches utilizing large buses as their primary means of transportation.

### **Bottom line**

We want to make this as easy as possible for you, but we need you to understand that some weeks may have scenarios which require the provision of additional transportation, whether through personal or rented vehicles.

### **Bus Drivers**

If your group comes on a chartered bus to M-Fuge and you plan on using that charter bus as your transportation to ministry site, you will need to secure lodging for the bus driver. The bus driver is welcome to be considered as one of your adult chaperones, as long as they will participate in supervising your students and you trust them to do so. If this is the case, you can just register him/her as an adult sponsor in your group numbers. If you do not wish to have the bus driver serve as an adult chaperone, you will need to make arrangements for his/her meals and lodging off campus.

## **PARTICIPANT FORM INFORMATION**

Every person coming to camp (adult sponsors and students) needs to complete two Fuge Participant Forms. Both copies need to be notarized.

You can find the Participant Form in the Appendix of this document.

If for some reason, a student or adult in your group does not want to provide their social security number, please have them complete the “Refusal/Absence of Vital Information Form” that can also be found in the Appendix of this document.

You will also need to complete and bring with you the Mississippi College Compliance Form which is located in the Appendix. Only one of these forms is needed per church.

## M-FUGE MINISTRY TRACKS

Upon arrival at registration, your M-Fuge students will sign up for their ministry track for the week. They will participate in these ministries in the afternoon each day. Their options are:

### **CHILDREN'S MINISTRY**

This ministry track involves working with children in a variety of settings including: Vacation Bible Schools, Backyard Bible Clubs, Day Camps, and other site-specific work with children. The purpose of this track is to minister to children, providing your students with the opportunity to teach and lead children in telling Bible stories, making crafts, and playing games.

### **SOCIAL MINISTRY**

This ministry track provides students a variety of ministry opportunities for meeting the physical, emotional, mental, and spiritual needs of people. Students in this track may minister in: mentally/physically handicapped centers, homeless shelters, soup kitchens, food banks, clothing closets, furniture distribution centers, refugee ministries, centers for teaching adults and children English as a second language (ESL), prison ministries, Baptist Centers, Salvation Army Sites, and other community organizations with like purposes.

### **PAINTING, CONSTRUCTION, AND YARDWORK MINISTRY**

Students in this track will spend their doing light construction work, roofing, repairing, cleaning, painting, and doing yardwork. These tracks work with various organizations such as Habitat for Humanity and local housing authorities.

### **CREATIVE MINISTRY**

This ministry track uses the gifts and abilities of students to minister through drama, interpretive movement, puppets, clowning, singing, and other ministry performances. Students in this track will spend their week traveling to nursing homes, children's centers, residential homes, beaches, parks, and other places where they will be able to minister creatively.

### **GAMES AND RECREATION MINISTRY**

This ministry track is designed to help students use their athletic ability and willing hearts to share the gospel through sportsmanship and Christ-like attitudes. These tracks are located in children's centers or homes, apartment complexes, and boys and girls clubs.

## ARRIVAL AT CAMP

When you arrive to camp this summer, you will need to bring the following with you (both of which are included in this document):

2. Mississippi College Compliance Form. You will only need to fill out one of these per church. This form is located in the Appendix.

You should not have to bring payment with you, unless you have changes at the last minute, as payments are due two weeks prior to arrival at camp.
