The House and Senate were in session last week and will return to Harrisburg on Monday March 21.

General Assembly Sends Supplemental 2015-16 State Budget to Governor for Approval Amid Veto Threat

No, faithful Week in Review readers you are not suffering from a case of de ja vu, the General Assembly has in fact sent a \$6.05 billion supplemental 2015-16 appropriations bill, fiscal code as well as non-preferred legislation for higher education institutions to Governor Tom Wolf and he has threatened to veto the legislation.

The legislation sent to the Governor is the final spending authorizations for FY 2015-2016 after Governor Wolf line-item vetoed a bill in December. The real buzz in the Capitol is whether or not the votes exist to override the Governor's veto if and when it happens. Sources are indicating that they have the votes, but we will not know until next week. *So be sure to check back next week to see if it is the final time we begin this newsletter with an update on the 2015-16 state budget.*

House State Government Committee Approves Executive Session Bill

Last week, the House State Government Committee amended and reported out House Bill 340 which amends the state Sunshine Law. The bill would significantly narrow the scope of what may be discussed in an executive session as it relates to personnel issues. HB 340 would also require a legal opinion by the township's solicitor verifying that the personnel issues to be discussed in executive session are within the provisions of the law, and if the solicitor is not available to render the decision, the chairman of the board could make such a determination. The legislation would also mandate that these private sessions be audio and video recorded. This legislation will now move to the full House for their consideration. **PSATS is opposed to this legislation.**

Thank you to the members of the Grassroots Network that responded to our action alert last week and contacted their House members urging them to oppose this bill. **If you have not already done so, PSATS is still asking members of the Grassroots Network to contact their House members and ask them to oppose HB 340 when it is considered by the House.**

House Labor & Industry Committee Hearing to Consider Prevailing Wage Reform Bills Cancelled

On Monday March 21, the House Labor & Industry Committee was scheduled to consider HB 63 (PN 0258), HB 1234 (PN 1619), and HB 1639 (PN 2387) which would amend the Prevailing Wage Act. PSATS supports these bills and thanks all Grassroots members that responded to our prevailing wage alert last week. Unfortunately, the hearing has been cancelled.

The pieces of legislation that were scheduled to be considered are detailed below:

[House Bill 63 \(PN 0258\)](#) would amend the Prevailing Wage Act (*Act 442 of 1961*) to increase the prevailing wage threshold from \$25,000 to \$190,000. This increase would account for inflation since 1963, when the \$25,000 threshold was set, and bring relief to local governments and their taxpayers. This legislation would also authorize the rate to be adjusted annually based on the Consumer Price Index.

[House Bill 1234 \(PN 1619\)](#) would amend the Prevailing Wage Act (*Act 442 of 1961*) to require that at least 51 percent of a project be paid for by public monies before it is covered by the Act. Under current law, any public or private project that is in excess of \$25,000 that is paid for in whole or in part with public funds is subject to the Act.

[House Bill 1639 \(PN 2387\)](#) would expand the definition of maintenance work to include work performed on dirt, gravel, and low-volume road maintenance projects. When Act 89 of 2012 was being discussed for consideration the increase of the prevailing wage threshold for municipal road projects was intended to include dirt and gravel roads. Since the law was passed, the state Department of Labor & Industry has determined that dirt and gravel roads are not covered under the Act and as such this legislation is needed.

Local governments are currently mandated by state law to pay prevailing wages on any public works construction contracts, excluding certain road projects over \$25,000. Studies have shown that paying the prevailing wage can increase the cost of public projects, financed by taxpayer dollars, from 15 to 30 percent. PSATS supports meaningful prevailing wage reform that would reduce the costs of compliance for this unfunded mandate.

Investment Bill Sent to Governor for Approval

The House recently concurred on the Senate's amendments to HB 1296 and sent the bill to Governor Wolf for his approval. HB 1296 would amend an existing law to give all political subdivisions increased flexibility in investing local funds while prohibiting risky investments. The legislation would expand the permissible financial products in which all municipalities and school districts may invest their general funds. HB 1296 would allow political subdivisions to invest in additional types of securities that are presently permitted investments for local governments in other states. This legislation specifically incorporates important safeguards for these investments, such as credit quality, maturity criteria, and valuable risk management tools. This proposal would allow local governments to invest in high quality money market instruments, negotiable certificates of deposit, banker's acceptances, and corporate notes. HB 1296 would provide local governments with the option to invest in additional high quality securities while at the same time providing appropriate risk management strategies to protect.

PSATS has sent Governor Wolf a letter asking for his approval of this legislation.

Public Employee Retirement Commission Meeting

The Public Employee Retirement Commission (PERC) met briefly last week to discuss the current status of PERC after a temporary order from the Commonwealth Court stated that PERC should continue to carry out its function by its staff (now assigned to the Governor's Budget Office) pending the outcome of a May hearing. The Commission tabled the ratification of the inter-agency agreement between PERC

and the Office of the Budget, as their decision hinges upon the outcome of the May hearing. The members voted to appoint the Attorney General as counsel for the Commission in response to the litigation brought by Representative Bloom and Representative Grove against the Governor.

House Special Election Results

Congratulations are in order for the winners of last week's special election contests for the Pennsylvania House of Representatives. The winners were Eric Neilson in the 57th district, Lynwood Savage in the 192nd district and Tonyelle Cook-Artis in the 200th district. *PSATS looks forward to working with the newly elected lawmakers.*

White House Close to Finalizing New Overtime Rules

The federal Labor Department sent the overtime rule to the White House's Office of Information and Regulatory Affairs (OIRA) last week for final approval. The final details of the rule have not been made public. However, the overtime rule, as it was proposed previously, would require employers to pay overtime for employees who make less than \$970 a week, or \$50,440 a year. Under current law, salaried workers who are considered exempt from the Fair Labor Standards Act who make more than \$23,660 a year are not required to receive overtime pay.

Senate Passes Bill to Combat Opioid Abuse

The Senate passed the "Comprehensive Addiction and Recovery Act (CARA) of 2016" (S. 524) The measure, authorizes \$77.9 million in grants per year, from fiscal years 2016-2020, to be awarded by the

U.S. Department of Health and Human Services (HHS) and the U.S. Department of Justice (DOJ) to combat a growing epidemic of prescription opioid abuse. Authorized funds could be used for treatment and recovery services, alternatives to prison for nonviolent offenders, law enforcement initiatives, and programs to prevent overdose deaths and improper prescriptions. Eligible recipients would include state, local, and tribal governments, educational institutions and nonprofit groups.

White House Announces ConnectALL Initiative

President Obama announced ConnectALL, an effort aimed at connecting 20 million more Americans to broadband Internet by 2020. The Obama Administration also announced its recommendation that the Federal Communications Commission (FCC) reform the Lifeline program to address the way people communicate in the 21st century. The Administration also released a new study on the economic importance of broadband and calling for nonprofits, businesses, technology experts, and government to join a national effort to reach the ConnectALL goal of connecting 20 million more Americans to broadband by 2020.

DOT Announces Procedures for Repurposing \$2 Billion in Highway Money From "Dead Earmarks"

The U.S. Department of Transportation announced the procedures for allowing states to redistribute almost \$2 billion in highway funding from "dead earmarks" made by Congress in old surface transportation authorization or appropriations bills. States and territories will have until September 12, 2016 to re-designate some \$1.958 billion in funding for new projects, which must then be legally obligated by the end of fiscal year 2019 (i.e. Sept. 30, 2019). To qualify as a "dead earmark," funds must have been provided by legislation that was at least 10 years old and for which less than 10 percent of the funding originally provided had actually been obligated.

Legislative Action

Township-related legislation that saw action this week in the Pennsylvania General Assembly:

Medical Marijuana: [SB 3 \(PN 1609\)](#) would establish a medical marijuana program in Pennsylvania. Specifically, the legislation would require a grower/processor to only grow and process marijuana in an indoor, enclosed, secure facility, require a dispensary only dispense medical marijuana in an indoor, enclosed, secure facility, and stipulate that a grower/processor or a dispensary may not be located within a 1,000 feet of any school or day-care center, *unless the facility is located in a Keystone Opportunity Zone*. SB 3 would also require the establishment of no fewer than three regions for the purpose of registering growers/processors and dispensaries, initially limits growers/processors to no more than 25 statewide, as well as initially limiting dispensaries to no more than 50, but each dispensary may have three separate location (for maximum of 150 locations statewide). A grower/processor shall be required to meet the same municipal zoning and land use requirements as other manufacturing, processing and production facilities that are located in the same zoning district and a dispensary shall meet the same

municipal zoning and land use requirements as other commercial facilities that are located in the same zoning district.

Action: Third consideration and final passage in the House as amended (149-43).

Status: Received as amended in the Senate and referred to the Executive Rules and Nominations committee.

Industrial Hemp Pilot Program: [SB 50 \(PN 1597\)](#) would create an Agricultural Pilot Program for the growth, cultivation and marketing of industrial hemp for institutions of higher education within the Commonwealth and the Department of Agriculture.

Action: Third consideration and final passage in Senate (49-0).

Status: Before the House Agriculture & Rural Affairs Committee.

Municipal Borrowing: [SB 340 \(PN 1608\)](#) would amend the Local Government Unit Debt Act (LGUDA) by requiring local governments to file a formal notification with the Department of Community and Economic Development before incurring debt, which would include justification for the borrowing and proof that it was current on all annual financial filings. SB 340 would also restrict local governments from guaranteeing another local government's debts and prohibit reimbursements for payments made under a guarantee or other non-project-related costs.

Action: Reported as amended from the Senate Appropriations Committee.

Status: Before the Senate.

Authority Debt: [SB 341 \(PN 475\)](#) would require indebtedness of an authority to be used for its declared purpose.

Action: Reported from the Senate Appropriations Committee.

Status: Before the Senate.

Interest Rate SWAP Agreements: [SB 342 \(PN 1383\)](#) would place additional restrictions on local government's use of interest rate swap agreements and require new provisions for such agreements to protect taxpayer funds.

Action: Reported from the Senate Appropriations Committee.

Status: Before the Senate.

Performance Bonds: [SB 344 \(PN 478\)](#) would amend the Public Works Contractors' Bond Law of 1967 to more clearly define the types of acceptable financial security that may be used under the act.

Action: Reported from the Senate Appropriations Committee.

Status: Before the Senate.

Heritage Areas Program Act: [HB 1605 \(PN 2320\)](#) would establish the Heritage Areas Program Act, which would provide guidelines for how the state Department of Conservation and Natural Resources (DCNR) administers State Heritage conservation programs. This program was established in 1989 and has operating since 1989 then without any statutory guidelines. The program is to stimulate community revitalization and economic development through recreation, tourism, and other partnerships.

Action: Third consideration and final passage in the House (191-0).

Status: Awaiting committee assignment in the Senate.
