## Appendix A - Reminders to CHEER users

1. Only CHEER's registered users can join CHEER's programmes by completing programme application forms.
2. All programmes will start on time; late arrivals may result in forfeiting the chance to join the enrolled programmes.
3. All participants should cooperate with and follow the instructions of CHEER staff and tutors.
4. You should take care of your personal belongings and property.
5. Parents and guardians are responsible for their own safety and the safety of their children. Parents and guardians should keep an eye on their young children to protect them from possible harm.
6. Report immediately and seek help from CHEER staff if you encountered any accident or injury in any CHEER activities.
7. All CHEER users must comply with all rules, regulations and laws of CHEER and Hong Kong. Illegal behavior and action will not be tolerated.
8. Consumption of alcohol and smoking are prohibited in CHEER Centre and programmes. CHEER staff has the right to confiscate any cigarette and alcohol brought by users.
9. **Cancellation due to low enrollment rate:**  
CHEER staff will inform you before the scheduled programme date in case of cancellation/ rescheduling.
10. **Cancellation due to bad weather:**

**\*1:** If the activities and programme will be held outside for a period of time, staff should decide whether to continue the activities and programme or not according to the safety of the participant's.

**\*2:** All outdoor and water activity/ programme will be cancelled.

**\*3:** Staff will decide whether continuity of activities and programmes according to the weather conditions and will notify participant as soon as possible.

**\*4:** Staff will advise service users to go home as soon as possible.

**\*5:** The Centre will be closed immediately. Centre's staff will notify all persons in the Centre as soon as the Hong Kong Observatory made an announcement of issuing Black Rainstorm Signal or No. 8 Cyclone Signal and arrange for them to leave the Centre safely before the signals are hoisted.

**\*6:** When the No. 8 Signal is cancelled or lowered, the Centre will re-open within 2 hours. But if the Centre is due to close within 3 hours after the typhoon signal is lowered, the Centre shall remain closed.

**\*7:** When the cold or very hot weather warning is issued during outdoor activities and programmes are taking place, staff will make a decision to continue or suspend the activity or programme.

**\*8:** Staff will notify all participants in the case of cancellation due to High Air Pollution Index.

**\*9:** If it's decreased to No.1/Amber rainstorm signals from higher signals 3 hours or more before the planned programme time, programme should resume proceeding except special notification is made to participants.
