#### What is ACAP?

The Accounting Career Awareness Program (ACAP), a part of NABA's Center for Advancement of Minority Accountants (CAMA), is an innovative career development program designed specifically for minority students who are juniors and seniors in high school. Its primary objective is to increase the number of high school students from under-represented ethnic groups that attend college and major in accounting.

The program will be held July 19 - 24, 2009, at the University of Minnesota, Twin Cities Campus Minneapolis, MN. During this program 40 students will have the opportunity to explore careers in accounting and business via a rigorous class and study schedule, college-level content and valuable networking opportunities.

ACAP will introduce minority high school students to accounting, finance, economics, technology and management while providing the foundation of financial literacy and the development of interpersonal skills. Prominent local business leaders will share their knowledge, provide tips for success and discuss educational opportunities. Participants will also experience accounting first-hand through tours of local companies and discussions with financial leaders. The program concludes with a recognition luncheon for students, parents, speakers, and corporate partners.

ACAP is a unique pipeline from high school to college that allows students to become prepared and informed about the expectations of college life. The program is fully supervised and all-expenses-paid. Students selected for ACAP will receive free tuition, room and board, books, materials, tours and mentoring.

#### PARTICIPANT CRITERIA

The student selection process is competitive. Participants must complete an application form, secure letters of recommendation, and write a statement of interest. The chart below shows the participant criteria for the ACAP summer residency program:

- As initially established, to operate in the spirit of the program, students participating in ACAP should be ethnic minorities.
- Participants in ACAP should be students entering primarily their junior or senior year in high school, with some exceptions to include sophomores.

#### **Details:**

ACAP will be facilitated by a combination of NABA members, University of Minnesota faculty and staff, and Corporate Partners. The program will include information on transitioning into college, better understanding the world of business, accounting and finance. Students will also complete a case presentation.
