## Waiver, Release, Consent and Covenant Not to Sue

In consideration of the Shiloh Tactical Shooting Club (from henceforth referred to as STS) and Shiloh Shooting Range (from henceforth referred to as SSR) permitting me to engage, participate or witness the firearms shooting activities of the STS wherever the same are held, I, \_\_\_\_\_ on my own behalf and on behalf of my heirs, representatives, administrators and assigns, hereby waive and release any and all claims, demands, causes of action, suits and rights I, or anyone on my behalf, might have against the STS, its officers and/or directors for personal injury (including death), loss or damage to my property which I (or anyone claiming by or through me) may have against the SSR, its officers and/or directors, as a result of my taking part in the firearms shooting activities sponsored by, sanctioned by or approved by the STS, its officers and/or directors.

Further, I agree that I will not, nor will anyone acting on my behalf claiming by or through me, bring or maintain any suit in any Court to assert any claim against STS, its officers and/or directors, for any claim that I might have arising out of my participation in any activities sponsored by, sanctioned or approved by the STS, its officers and/or directors.

I recognize that the STS and SSR, its officers and/or directors are not obligated to permit me to participate in any of the STS activities and may terminate my participation in such activities at any time and for any reason.

Additionally, I agree to the publications of my name and likeness.

**I UNDERSTAND THAT ENGAGING IN FIREARMS SHOOTING ACTIVITIES CONSTITUTES MY INVOLVEMENT IN A VERY HAZARDOUS AND DANGEROUS ACTIVITY WITH ACCOMPANYING RISKS OF PERSONAL INJURY OR DEATH AND LOSS OR DAMAGE TO PERSONAL PROPERTY, AND I HEREBY VOLUNTARILY ASSUME THOSE RISKS. MY SIGNATURE ON THIS DOCUMENT CERTIFIES THAT I AM AT LEAST 21 YEARS OF AGE AND THAT I MAY LEGALLY POSSESS FIREARMS AND THAT I WILL NOT USE ANY SKILL I LEARN WHILE PARTICIPATING IN THE AFOREMENTIONED EVENTS FOR ANY ILLEGAL ACTIVITY.**

**This instrument shall remain in full force and effect indefinitely.**
