This contract is subject to the following stipulations:

- 1) The suspension or termination of membership in the NCWA by either party shall render this contract null and void. All rules and regulations of the NCWA apply as part of this contract. The NCWA shall have full authority to specify terms of settlement in any controversies under the provisions of this contract.
- 2) **Selection:** All NCWA programs in good standing are eligible to apply to the National Duals Selection Committee (NDSC) for inclusion in the Duals. All interested teams shall submit this signed contract to the Executive Board by December 1, 2018 in order to be placed in the applicant field. The NDSC shall consist of the NCWA Executive Board and the eight Conference Chairmen. The role of the NDSC shall be to invite up to 16 member teams to the National Duals. Teams in the applicant field that placed in the top-6 at the prior National Duals shall have their bid accepted. The remaining teams will be ranked by the NDSC using competition results (if possible) and NCWA rankings available on December 1, 2018. Selection of the teams shall be limited to NCWA-D1 programs and the top-5 returning NCWA-D2 programs from the 2018 NCWA National tournament. By December 15, 2018, invitations will be extended to the teams based on the NDSC's rank order until a field of no more than 16 teams has been determined.
- 3) **Financial Agreements:** The entry fee for the National Duals will be \$500 and due by January 1, 2019. A late fee of \$100 may be assessed for each week past the deadline. School purchase orders are acceptable in lieu of immediate payment. All fees are non-refundable. Failure to compete in the National Duals after being accepted may result in a \$500 fine. *Once this signed contract is received AND accepted by the NCWA, your team entry fee will be posted on your NCWA website team page for payment/processing. OR make checks payable to: NCWA and send to: 8737 Grenadier Drive - Dallas, TX 75238-3819.*
- 4) **Other Specific Agreements:** The format of the tournament is dependent upon the eligible contracted teams at December 31st each season. The site of the National Duals will be chosen by the NCWA Tournament Committee and contracted by October 1st of each season. Seeding will be conducted by the Tournament Director with the input of participating teams and the Tournament Committee prior to the event.
- 5) **National Points:** All NCWA Programs, in good standing, are eligible for an invitation to the National Duals. Placement in the top-16 at the National Duals will earn each team that is eligible points towards the **Grand National Team Championship** to be awarded after the NCWA Nationals in March 2019 (Champion = 20 pts down to 16th place = 5 pts). No team will be allowed to compete in the event without a signed contract and payment being completed. Teams will not be awarded Nationals Team Points with less than 8 weight classes filled at the beginning of the National Duals tournament. Teams leaving before fulfilling their contractual obligations will also forfeit Nationals Team Points.
