## WELCOME

The Pullman Parks & Recreation 3-on-3 Lentil Festival Hoop Classic basketball tournament will be held in Reaney park on Saturday, August 18th, 2018. The following information is provided to help you with registration and give you a brief understanding of the rules.

## PACKET PICKUP

Registered teams should pick up packets which include t-shirts (max. 4 per team) on Friday, August 17th at the Pullman Parks & Recreation Office located in Pioneer Center, 240 SE Dexter St. between 8:00 a.m. and 5:00 p.m., or at Reaney Park from 8:00-8:45 a.m. on Saturday, August 18th.

## PARKING

There will be no parking in or around Reaney Park during the Lentil Festival. We suggest using the Pullman City Playfields, nearby WSU parking lots, or Simpson Methodist Church lot at 325 NE Maple St.

## WEATHER

Games may postponed, moved, or cancelled due to adverse weather conditions. If cancelled, refunds will be prorated depending on costs incurred by the tournament.

## TEAMS

Teams are allowed a minimum of three and a maximum of four players. All games must begin with three players on each team.

## GAMES

Games are played to 20 points or 25 minute time limit, whichever comes first. Each basket or free throw is worth one point, and a shot made behind the three point line is worth 2 points. Each team is allowed (1) one minute time-out per game.

**ASSUMPTION OF RISK AND RELEASE OF LIABILITY**

In consideration for being allowed to participate in the Lentil Hoop Classic 3-on-3 Basketball Tournament on August 18, 2018 (the "Activity"), I, the undersigned adult, on behalf of myself and my child(ren) assume all risks and hazards reasonable related to the Activity. Further, I do hereby release and hold harmless the City of Pullman, its elected and appointed officials and employees, organizer, sponsor, supervisor, contracted facilitator, or any volunteer connected with the Activity. I understand that direct supervision will not be provided and by participating in the Activity, I expose myself to the risk of injuries including but not limited to temporary or permanent muscle soreness, sprains, strains, cuts, abrasions, bruises, ligament and/or cartilage damage, head, neck or spinal injuries, loss of use of arms and /or legs, eye damage, disfigurement, drowning or death. I also recognize that there are both foreseeable and unforeseeable risks of injury or death that may occur as a result of my participation in this Activity which cannot be specifically listed. Further, I recognize that the actions of other people either affiliated with the Organizers listed below may cause harm or loss to my person or property. I acknowledge that I have familiarized myself with the description of the Activity, and understand the hazards, my child(ren)'s personal limitations, and knowingly assume all risks. In the event of an medical emergency, I authorize transportation to the nearest appropriate medical facility, and authorize emergency medical care if I cannot be reached. In the absence of a signature, payment of fee and participation in the Activity shall constitute acceptance of the conditions set forth in this release. I grant full permission to use any photographs, videotapes, motion pictures, recordings or any other record of this program for any City of Pullman informational or promotional use.

**Release of Liability**

In further consideration for being allowed to participate in the Activity, I hereby release and hold harmless the City of Pullman, the Pullman Chamber of Commerce, the National Lentil Festival, Gritman Medical center, and all of their respective officers, employees, agents, and representatives (hereafter "Organizers"), from any and all liability, claims, costs, expenses, injuries, or losses, including those resulting from the negligent acts or omissions of the Organizers, that I may sustain as a result of or in relation to my participation in the Activity. I also release the Organizers from loss or damage to my person or property caused by other people either affiliated or not affiliated with the Organizers, and I will indemnify (including reimbursement and defense as defined under law) and hold harmless the Organizers from any loss or damage which may arise from negligent acts or omissions.

In any part or portion of this Assumption of Risk and Release of Liability is determined to be invalid or unenforceable, the remaining parts or portions shall be enforceable.

I have carefully read this Assumption of Risk and Release of Liability and fully understand its contents. I am aware that this Assumption of Risk Liability is legally binding and I sign it of my own free will.
