Let me now give highlights on the growth of the company. Despite the industries muted growth and volatility in raw materials price, the company reported a 12% overall volume growth and improvement in gross margins by 150 bps. This improvement in gross margins our strong fundamentals and capabilities to perform during challenging periods. During the year under review, we have commercialized a 4,50,000 square feet state of the art manufacturing term warehousing facilities spread over five acres of land at Jagadishpur Hosiery Park, Kolkata. This facility aims to enhance workflow by reducing vertical movement and supporting local economic growth through job creation, sustainability and industrial development. The company introduced Ranbir under its Luxury brand (Not Clear) extending its seasonal coverage throughout the year. -- The company's commitment to process a complete and multi season apparel portfolio. Following the success of Lyra Lingerie lying for mid premium segment, the company launched a linguistics brand Lux Venus hub for the economic segment and its Lux brand Lux Venus, expanding its customer base and boosting profitability. The company also launched Lux Cozy Boys, a kids gear inner beer range under the brand Lux Cozi, for children aged 3 to 14 years not clear at Lux has transformed the company, enabling direct engagement with our 1.5 lakhs retailers and providing real time consumer insights. The ongoing initiative improves working capital cycles, inventory turnover, capital efficiency and margins will be reducing overhead. E commerce has become a vital part of the retail landscape and at Lux industries we are focused on implementing data driven strategy to enhance our online sales. Lux has always believed on giving back to society. This year, your company contributed an amount of 6.43 crores towards our CSR initiatives. The statutory auditors and the Secretarial auditor expressed unqualified opinion in the respective audit report for FY 23-24. There were no observation, qualification or adverse remark on the financial statement and matters which have any material bearing on the functioning of the company. As mentioned in the notice, those members who did not or could not avail the remote E voting facility can avail of the facility to cast their vote electronically during the AGM on all proposed resolution through K Fin's Insta poll mechanism.
