#### IV. VISIONING SESSION

Chairman, John McDonnell introduced Greg Almieda from Global View Communications, who presented briefly to the Committee members with a working session to follow.

Workforce Analysis Baseline Summary

Diversity perceptions are not factored in when reviewing availability data, comparisons to labor market data should not be used as a sole measure of success.

Workforce analysis was done by comparing the racial composition of specific occupation categories of the MCCA workforce to external availability by race in those same categories. Purely from a statistical standpoint a review of workforce data shows there are no glaring deficits in workforce representation with African-Americans. On the other hand, Latinos are significantly under-represented in Building Operations and Clerical. Asians are underrepresented in all categories including management. The perception of unfair treatment and lack of diversity focus outweighs the data showing workforce representation among African-Americans is in most cases higher than external availability.

The specific public allegations call for a more intentional approach to diversity recruiting as a proactive measure.

MCCA Building Operation & Clerical Employee Demographics

The MCCA trends slightly whiter among its clerical employees versus the Greater Boston area, and slightly less white among its building operation employees versus the Greater Boston area. Clerical employees: 2.3% more white than the clerical workforce in Greater Boston. Building operation employees: 0.7% less white than the building operation workforce in Greater Boston.

In those same categories, the MCCA significantly under-indexes among Hispanic & Latino employees versus the Greater Boston area. The organization also somewhat under-indexes among Asian employees. Overall, the MCCA is 6.6% less Hispanic/Latino than Greater Boston's building operations & clerical workforce. Similarly, the MCCA is 4.0% less Asian in those same roles.

The MCCA over-indexes among Black & African American employees in building operations (by 10.5%) and clerical roles (by 8.4%).
