IV. PERSONNEL UPDATE

Devin Taylor, Human Resources Director, gave a brief update to the Committee. Ms. Taylor proposed a review from the Executive Committee to adjust highly compensated employee salaries to reflect a 3% adjustment effective 7/1/23, and a flat-rate bonus of \$1500. This adjustment would reflect the same rate adjustment and flat-rate bonus, issued to all eligible MCCA employees on July 1, 2023. Additionally, Ms. Taylor presented to the Committee on Executive Director, David Gibbons' bonus is incentive pay that is outlined in his employment agreement. Upon approval of the Committee, the Executive Director is eligible for additional incentive compensation for each year in which he provides services hereunder in an amount not exceeding (10%) of his base compensation in such year.

V. BOARD VOTE: Bay State Cruise Company Contract Extension

Shannon Smith, Director of Transportation, presented the following vote to the Committee.

The Massachusetts Convention Center Authority's ("Authority") Transportation Department desires to extend the contract with Bay State Cruise Company to align with the existing term of its contract with the private companies that fund the ferry service. This allows us to guarantee our ability to meet the terms of the ferry operations contract within the costs outlined therein.
