
Grains closed higher today and for the week. Soybeans provided price leadership today. USDA reported new sales in the daily system again today:

- Export sales of 210,000 metric tons of corn for delivery to China
- Export sales of 132,000 metric tons of soybeans for delivery to China.
- Export sales of 100,00 metric tons of soybean meal for delivery to unknown destinations.

USDA announced CFAP2 today and the 2nd version of the program is very much like the first. A 5% price trigger is in place is similar to the prior rules.

Commodity funds added to their net long positions today and this week (see page 4.)

Soybean and corn harvest pace is slowly increasing.


