

Futures Closes

Wheat and corn futures closed lower today while soybeans closed higher. Commodity funds were net sellers of 24k corn and 6k wheat contracts. Funds were net buyers of 7k soybean contracts. Weekly export sales were below expectations for corn, soybean and wheat. Corn lags pace 9% to meet the USDA export projections, soybeans 16% and wheat 3%. China did come to the US for sorghum validating that their Phase 1 assertion that their decisions would be market based is true. US sorghum is priced at \$162.50 while Australian sorghum is priced at \$267.78. Farm Futures says their survey indicates farmer corn planting intentions of 96.6 mil acres. The coronavirus now stands at 82,550 cased reported with 2.810 deaths and continues to burden commodity and equity markets with strong risk aversion.
