STORAGE CHARGES

Corn - \$.17 minimum to Jan 15, then \$.03 per month. Beans - \$.19 minimum to Jan 15, then \$.035 per month.

CORN

Maximum Moisture is 34%. Corn shrunk to 15% to sell and 14% for storage.

Each load will stand on its own for all grade factors.

Drying charges will be deducted at the time of settlement for corn that is sold.

Drying charges will be billed and due by January 2, 2021 for stored corn.

SOYBEANS

Soybeans will be shrunk to 13.0% moisture.

Soybean shrink factor is 1.5% per half point of moisture for beans 13.1% to 15.0%.

Soybean shrink factor is 2.0% per half point of moisture for beans over 15.0%.

All other grade factors will be on a load by load basis.

Each load of grain not sold 7 days after delivery will be placed in storage.

2019 CARRYOVER GRAIN

Daily Rate will continue with no new minimum on Price Later grain. Open storage grain will have a new minimum storage charge added on 9/1/20. Open storage grain can be moved to Price Later and will not incur a new minimum charge but will continue at the daily rate. Contact us if you would like to do this. Accrued charges on all grain through 8/31/20 will be billed and due by 9/20/20.
