SCHOLARSHIP REQUIREMENTS

- Applicant must be a high school senior graduating in the spring of 2018 from a School within Farmers Ranchers Cooperative's trade area.
- Applicant must have a cumulative high school grade point average of 2.5 or better on a 4.0 scale.
- Applicant must plan on attending an accredited post-secondary school pursuing a career in agriculture or entering an ag-related field of study.
- Parents/Guardians of applicant must be a member or become a member of Farmers Ranchers Co-op
- Dependents of officers of Farmers Ranchers Cooperative are not eligible to apply for these scholarships.

- Two completed character reference forms from current or former employers, school officials, agribusiness leaders, mentors, etc. References should not be written by employees of Farmers Ranchers Cooperative.
