

From 1987 to 1992, Mr. McClennan was Vice President and CFO for Rueben/Prepared Foods, Inc., a subsidiary of International Multi-Foods. From 1985 - 1987, Mr. McClennan was Vice President of Finance, CFO, and Corporate Secretary for Wilton Enterprises, Inc. Prior to that time, Mr. McClennan spent seventeen years with Tenneco, Inc.; the last three years of which he was Senior Vice President of Finance of the Automotive Group.
