We are making this application and statement for the purpose of securing credit on account, and we represent that the information given herein is true and accurate. We authorize the references named herein, both financial institutions and suppliers, to release any financial information known to them, for the purpose of evaluating this application for credit. We agree to pay according to the terms of each account and request the billings be made in the account name specified. If a Service Fee is added, it is computed on the previous balance, less payments and credits appearing on the face of the statement, at a periodic rate of up to 2% per month. The minimum monthly finance charge will be one dollar. By the signature(s) below, I/we agree to be bound by Central Ohio Farmers Co-op, Inc. ("Coop") credit terms and acknowledge receipt of a copy of the credit terms. The Ohio laws against discrimination require that all creditors make credit equally available to all credit worthy customers, and that reporting agencies maintain separate credit histories on each individual upon request. The Ohio civil rights commission administers compliance with this law.

PAYMENTS TO CUSTOMER/RIGHT OF OFFSET: Payments due Customer from Coop for any commodities delivered or sold to Coop, discounts or any other rights to payment due Customer shall be subject to offset by Coop for any charges owed to Coop. The right of offset set forth herein shall include the right to offset payments against any debts owed by Customer to any division or subsidiary of Coop, including but not limited to Morral Companies LLC.

DISPUTE RESOLUTION. Notwithstanding any Confession of Judgment provisions contained in any agreement between Customer and Coop, Customer agrees that the sole remedy for resolution of any and all disagreements or disputes arising under or related to this Farm Credit Application or any other transaction between Customer and Coop (including, but not limited to, any statutory or tort claims arising from the relationship between the parties) shall be through arbitration proceedings before the National Grain and Feed Association (NGFA) pursuant to the NGFA® Arbitration Rules without the necessity of court order, provided further that Customer consents to enforcement of the obligation to arbitrate disputes in any state or federal court and expressly waives the defenses of personal jurisdiction and venue with respect to any such action. The decision and award determined through arbitration shall be final and binding upon the parties. Judgment upon the arbitration award may be entered and enforced in any court having jurisdiction thereof. The parties agree that any arbitration conducted hereunder shall be governed by the Federal Arbitration Act, 9 United States Code §§ 1-16, as now existing or hereinafter amended.
