- Purchased grain is due upon receipt of invoice.
- ▶ Price Later / Storage Fees will be billed 12/31, 3/31, 6/30 & 9/31.

CORN

Moisture

15% to 30 % - subject to drying & shrink (18% down avg by lot)

Over 30 % - subject to rejection

Drying -\$.035 per point (subject to market)

Shrink - 1.45 % per point

Test Weight

50.0 - 54.0 #'s - \$.02 per # per bu.

Below 50.0 - \$.03 per # (subject to rejection)

Foreign Material

Over 3 % - \$.03 per point (subject to rejection)

<u>Damage</u>

Over 5% - \$.02 per point (subject to rejection) Musty or Weevils - \$.10 per bu. (subject to rejection)

Sour or Heat - \$.20 per bu. (subject to rejection)

Custom Drying

In and out within 3 days – regular drying and shrink discount + \$.12/ bu. handling charge.

Drying of corn will be based on the difference of incoming moisture of corn and the outgoing moisture (no guarantees).

SOYBEANS

Moisture

13.1% - 15% = 3% shrink per point (14.5% down avg daily)

15.1% and above = 4% shrink per point

Foreign Material

Over 1% - deducted from gross weight

Over 5% - subject to rejection

Test Weight

54.0 #'s and under- \$.02 / # / bu.

Below 50.0 - \$.03 / # / bu. (subject to rejection)

Damage - current market discounts for: Damage, Splits, Green Beans, Heat Damage,

Musty, Sour, Cofo, Etc.

OUTBOUND CORN (all classes) will be credited for all applicable discounts as above.

Moisture over 15.5% will be credited @ \$.02 per point / bu. (averaged by lot)
