- * Corn that is Musty or Sour is subject to rejection. If accepted, the discount will be no less than \$.15 per bushel.
- * Corn that is infested is subject to rejection. If accepted, the discount will be no less than \$.25 per bushel.
- * Any load containing snow/ice/mud/dirt/stones will be subject to rejection or special discounts.
- * Any load containing soybeans or other grains is subject to rejection. If accepted, the discount will be \$.05 per % over 1.0%.
- * All Loads will be graded individually, there will be no averaging of any grade factors.
- * We reserve the right to reject any load for unacceptable quality
- * We reserve the right to retain and submit grain samples to an independent grain inspection agency and use their grades upon settlement.
- * Notification of ticket & contract splits should be done before or at the time of delivery.
