



2018 HARVEST POLICY
Effective September 1, 2018

SAFETY - While dumping grain, **PLEASE STAY IN YOUR VEHICLE.**

- **GRAIN DISPOSITION:** Customers will have **FIFTEEN (15)** calendar days for the average date of delivery throughout the year to state disposition of grain (i.e. for sale, storage, price later, grain bank, etc.). If not stated, **grain will automatically be placed in storage.** Individuals delivering grain will be responsible for **accepting grades for each load at time of delivery plus any splits on ownership.** The highest moisture or damage sample will represent the entire load.

IDENTIFICATION SIGNS: Upon your asking, we will provide signs for your delivery units when bringing grain to our facilities. **Make sure the correct name is on the scale ticket before leaving the scale when empty.**

CORN

- All drying will be charged at time of stated disposition and moisture is calculated on per load basis.
- Corn sold is shrunk to 15.0% and corn stored is shrunk to 14.0%.
- Shrink factors will be 1.425% per point of moisture removed per bushel.
- Drying:
 - 3.5¢ per bushel per point to the nearest tenth between 15.1%-18.0%
 - 4.0¢ per bushel per point to the nearest tenth between 18.1%-22.0%
 - 4.5¢ per bushel per point to the nearest tenth between 22.1%-25.0%
 - 5.0¢ per bushel per point to the nearest tenth between 25.1%-30.0%
 - 6.0¢ per bushel per point to the nearest tenth between over 30.0% & may be subject to rejection.
- Foreign Material:
 - 2.0¢ each 1% or fraction from 3.1%-4.0%
 - 4.0¢ each 1% or fraction from 4.1%-5.0%
 - 5.0¢ each 1% or fraction from 5.1%-10.0%
 - Above 10.0% is subject to rejection or discount as agreed upon by TBC and Seller.
- Corn testing over 20.0 ppb for Aflatoxin will be rejected.

SOYBEANS

- When selling, Moisture is 3.5% of the selling price per point between 13.1%-15.0%. Moisture over 15.0% is 5.0% of the selling price per point of moisture.
- When storing, Shrink factor will be 3.0% per bushel per point to the nearest tenth between 13.1%-15.0%.
- Soybeans are based on 13.0% moisture. Accepting moisture over 15.0% is based on ability to store.
- Foreign Material over 1.0% will be deducted from the gross weight.
- Soybeans will not be averaged and will be per load. Discounts are figured on a load-by-load basis.

STORAGE RATES: All grains will be subject to 5.0¢ per bushel for the **first 30 days** delivered between September 1st and December 31st. After this 30 day period, the storage rate will be 0.1667¢ per bushel per day through August 31st. After August 31st, the storage rate will be 0.1667¢ per bushel per day. All storage after the **30-day** minimum period will be accrued on a daily basis. Higher rates may apply on carry-over years.

Grain may be placed on a Deferred Payment Contract. According to Federal Warehouse Regulations, all Deferred Payment Settlement Contracts are final and cannot be changed. According to State Grain Regulations, grain settlements from the open storage position are final and cannot be reversed.
