Each Mokon system is guaranteed to be free from defective material or workmanship for the period stated. Please see below for specific warranty coverages by Mokon product.

### <sup>1</sup> Additional Warranty Coverage

Blown Film Cooler Systems – Cabinetry is covered by a lifetime warranty and the Blower Motors are covered by a two-year warranty.

Duratherm HTP and Duratherm MAX Water Systems – The standard microprocessor controller is guaranteed to be free of defective material and/or workmanship for three years.

Full Range Heating/Chilling Systems, Heat Transfer Oil Systems and Portable Chiller Systems – All standard microprocessor controllers are covered by a five-year warranty, microprocessors with special features are covered by a three-year warranty and solid-state controllers are covered by a one-year warranty.

## **Warranty Information**

Mokon warrants its products to be free from defects in materials and workmanship when used under recommended operating conditions and within the application the product was designed for. Mokon's warranty obligation is from the date of shipment and limited to the original customer - not transferable. Upon discovery of an alleged defect, the customer should contact the Mokon Service Department with the complete model number, serial number and the date of purchase.

Mokon's obligation under this warranty is limited to make good, from or at its factory, any parts that are returned to the company (prepaid) and deemed defective, within the period of the warranty. There is no labor component to this warranty, except when the refrigeration circuit of a chiller is found to be defective and needs to be opened. Refrigerant and any labor associated with its evacuation or replacement is not covered by this warranty for remote condenser systems. This warranty does not cover the cost of labor during overtime hours (after normal working hours or during weekends and holidays). Any cost differential for overtime labor will be the responsibility of the customer.

# Product Warranty



This warranty will be voided when, in Mokon's opinion, the equipment and/or system has been subject to misuse, negligence or operation in excess of recommended limits or has been altered and/or repaired without express factory authorization. Note the following conditions will void warranty:

- 1. If equipment is or was installed in hostile environments, unless such conditions were specified at the time of purchase;
- 2. The serial number has been removed or defaced;
- 3. The equipment is damaged caused by corrosion or freeze up;
- 4. The chiller was operated with automotive anti-freeze;
- **5.** The equipment was operated with any grease or fluids other than the type recommended in our instruction manuals, website or if not previously approved in writing by Mokon. Consult the Mokon service department with questions or requests to use materials not listed or approved for use.

The customer has the option of having a Mokon service technician or representing party come to its facilities (based on availability) if it issues a Purchase Order agreeing to pay for all reasonable labor time, transportation, food and lodging costs if the problem is not covered by this warranty. Repair and replacement in any manner provided above shall constitute a fulfillment of all liabilities of Mokon concerning the quality of the temperature control system.

No allowances, credits or reimbursements will be made for any replacement or repair made or provided for by the customer unless authorized in advance, in writing, by Mokon. Mokon is not responsible for any sales, use, excise or other applicable taxes associated with the replacement of parts under this warranty.

The warranty set forth above is in lieu of any and all other warranties expressed or implied including warranties of merchantability and fitness for a particular purpose. Mokon shall in no event be liable for any consequential damages or for any breach of warranty in an amount exceeding the original price.
