Hamilton Babe Ruth Facility Rental Policy

A person or group seeking use of the Hamilton Babe Ruth batting cage and/or baseball field must sign the application form stating that he or she has read and understands the rules, regulations and guidelines.

1. Please be aware that the signee of the application is waiving and releasing Hamilton Babe Ruth from any and all losses, claims, suits or judgments or damages for themselves and to the members of his/her group that might arise as a result of any and all activities connected with or associated with this Rental Agreement. Hamilton Babe Ruth shall assume no responsibility for any accident, theft or loss of property. Hamilton Babe Ruth shall be held harmless for any costs or liability resulting from activities or programs of the renter.
2. All participants must have a signed waiver on file prior to using the batting cage or field. If participants are under the age of 18, a parent or guardian must sign on their behalf.
3. Rental applications must be completed in full and signed by an adult who is 21 years or older. This person assumes responsibility for the group and must be present during the entire rental period.
4. Rental applications are considered on a first come, first served basis.
5. Full rental payment is required with the rental application and reservations are not secure until received.
6. Renters may not enter the batting cage or field prior to the agreed upon rental time.
7. Rental fees are charged for all time used in the facility. Set-up and clean-up time should be included in the rental reservation time requested. Unauthorized time used will be charged at a rate of \$15 for every 10 minutes.
8. Cancellation requests must be received in writing via email. A refund of rental fees will be granted minus a 10% service charge if requests are received 48 hours in advance. For requests received less than 48 hours in advance, rental fees are non-refundable. Rental area should be cleaned and left in the same condition as it was found to avoid a cleaning fee. A cleaning fee may be charged if the renter does not clean the area properly.
9. Hamilton Babe Ruth holds the right to cancel at any time.
10. Damage to Hamilton Babe Ruth property and/or equipment will be assessed after each rental. The individual signing the application is responsible for the balance and will be billed accordingly.
11. Video surveillance will be reviewed during or after each rental and could result in damage fees or banishment from the facility.
12. Facility rental policies are subject to change without prior notice.

I, the undersigned, have read, understand and agree to abide by Hamilton Babe Ruth policy, rules, regulations and guidelines for rentals and use of facility. I am also aware that in renting a facility for myself and/or for other participants I invite for participation in the above rental, I will be waiving and releasing all claims for injuries myself or my participants might sustain arising out of the above rental.

Batting Cage & Field Rules

Please Initial:

_____ * Rental groups must be supervised at all times by an adult.

_____ * The batting cage should not be left unattended.

_____ * Batting Helmets & athletic indoor shoes must be worn at all times.

_____ * Baseball/softball cleats (of any kind) are not permitted.

_____ * No live hitting outside of the batting cage (does not apply to field rentals).

_____ * Only one batter and one pitcher are allowed in the batting cage at a time while hitting live.

_____ * Helmet must be worn and pitching screen in place.

_____ * No pitching machines or yellow pitching machine balls are permitted without prior approval by HLL.

_____ * Do not climb or pull on net.

_____ * **No gum, food or beverages (plain water only) in batting cage.**

_____ * ***CAUTION! Injuries could result from the use of this area. Users should assume the inherent risks of flying baseballs and softballs. If users have any questions about the use of this device or the inherent risks associated with the use of this device, ask the attendant before using the batting cages.***
