- Items presented for possible Draft revisions
 - If a coach has two (or more I suppose) children in his draft (twins or otherwise) where do we
 put them on the draft board? With one child they becomes the last round pick, we need to
 decide where the other child goes and make it a rule.
 - Discussed having coaches child placed in the round according to their ranking from evaluation. Brian H suggested banding in all leagues. Another suggestion was to have league coordinator review sheets to make sure kids are in the right rounds. Ideas to think about and discuss further after the season.
 - In a situation where we have co-coaches where do we put their children on the draft board? Do they go to the final two rounds of the draft or does one go to the final round and one go to another, higher round? We need to decide where the other child goes and make it a rule. For coaches who do not have children playing in the league, it was suggested to me yesterday that we take the average scores of the other coaches children and then choose a player from the list

- with that score and assign that player to the child-less coach in the final round of the draft. Just putting it out there for discussion.
- We need to talk about setting stricter standards for parents in asking that certain coaches not be able to select their children. Not looking to make it more difficult, there just needs to be real reasons behind the requests and we can put this down in black and white as well.
 - Too many people did this this year. Some coaches didn't even know the player.
 Discussed having the league coordinator be the person that is told and requiring valid reasons for making this request.
