- Motion to approve May minutes 1<sup>st</sup>:Brett 2<sup>nd</sup>: Brian. All in favor with no abstentions.
- Treasurer's report Ed not present; Jeff provided report: numbers are solid for end of the season, raffle and snack shack deposits made. Umpire payments occur once weekly.
- EJBL parent with concerns about Post-Season team selection: A parent spoke his concerns that his son's coach did not provide adequate coaching given his other coaching commitments; another parent from the same team disputed the accusation and defended the coach with examples; Troy interjected to request that the discussion stay on the topic which he wanted to discuss: the all-star selection process. Tom asked if the parent was aware of how the players are selected. Since he was not 100% clear Troy explained the entire process with Andy providing corroboration and situational examples to justify choices made. Same parent questioned why the teams are the same year after year and wondered if there are ever any changes? Response: yes, some players performances fluctuate and players do change, but for the most part the top players remain on the team as they usually continue to perform at a high level. Andy conveyed the various ways we've added teams to keep players playing longer: 60' team for both 11 and 12-year olds and the 9/10 Tournament team. Keith voiced expressed the difficulty they have when it comes to selecting the last few players as sometimes they are performing at the same level. Another parent present spoke to some research he'd done on other teams' selection processes: secret ballot, midseason tryout. Troy noted that other processes have been tried in the past and that the process currently used produces the most competitive teams. The overall agreement voiced by various board members was that selection process in place is not 100% perfect, but the results prove that we are creating very competitive teams. Troy asked concerned parent if he was clear on the system in place and if he was satisfied with the answers he'd been provided with. Parent responded that he was. Brian motioned to create a subcommittee to re-evaluate all-star selection process. Agreed.
- Post-Season Tournaments Andy: Unknown when Cal Ripken meeting for district/state tournaments are

- Andy motioned to purchase portable batting cage to use for tournament then placed at Currier/Walsh for next season, Todd 2<sup>nd</sup> motion passes with majority rule, 1 against. **Apparel** Bob suggested securing a custom t-shirt vendor at the game rather than purchasing a large amount of apparel and it not selling. Agreed this was a better option. **Alternate field** if we have rain and have to move into playing games on Friday Kensington fields are not available due to town celebration. Various options discussed.
