2. All minors are required to wear a USA Softball approved face mask while in the field regardless of any positions. (Infield and outfield included).
3. All official USA Softball rules must be followed.
4. Under no circumstances are minors allowed to be pitchers.
5. If a minor chooses to catch, they are required to wear a Catcher's Helmet with Face Shield.
6. If an official determines that the minor is not fit to be playing, they may be removed from the game at any time, and the official's decision is final.

Refusal or Failure to abide by the participation requirements will result in the following:

The Team will receive one warning to comply with the above requirements.

- 1<sup>st</sup> offense – Automatic Ejection from that game.
- 2<sup>nd</sup> Offense – Termination of contract and ejection for the season (All games including substitution or other leagues, Districts, and State.)



This application can be terminated at any time, for any reason by any umpire, board member, or other official of the league. This application is null and void if minor and their legal guardian fail to sign and acknowledge the liability and indemnity waiver.
