- Trophies will be awarded to half the teams.
- Cheerleader of the Day trophies will be given for all divisions unless specified otherwise by team coaches.
- Coaches are responsible for their team's music. You are encouraged to bring 2 copies of the music. You must have someone available to play your music during your routine.
- Music Guidelines: All teams are required to follow the new music guidelines and provide a waiver guaranteeing music is within those guidelines.
