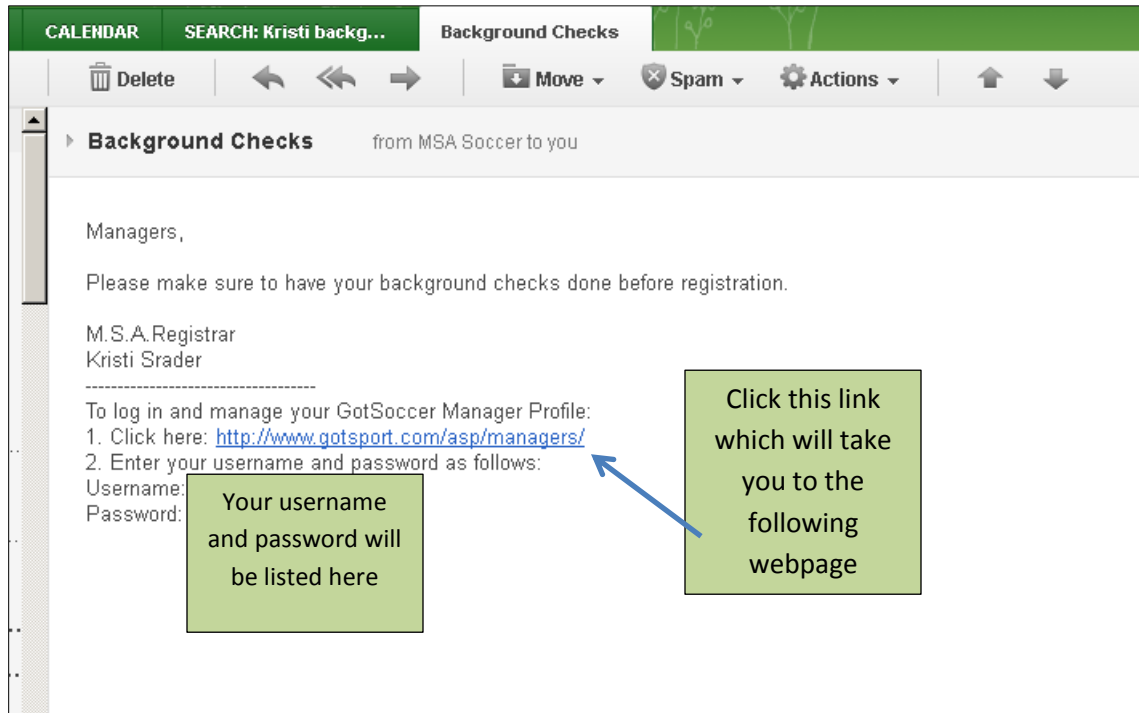
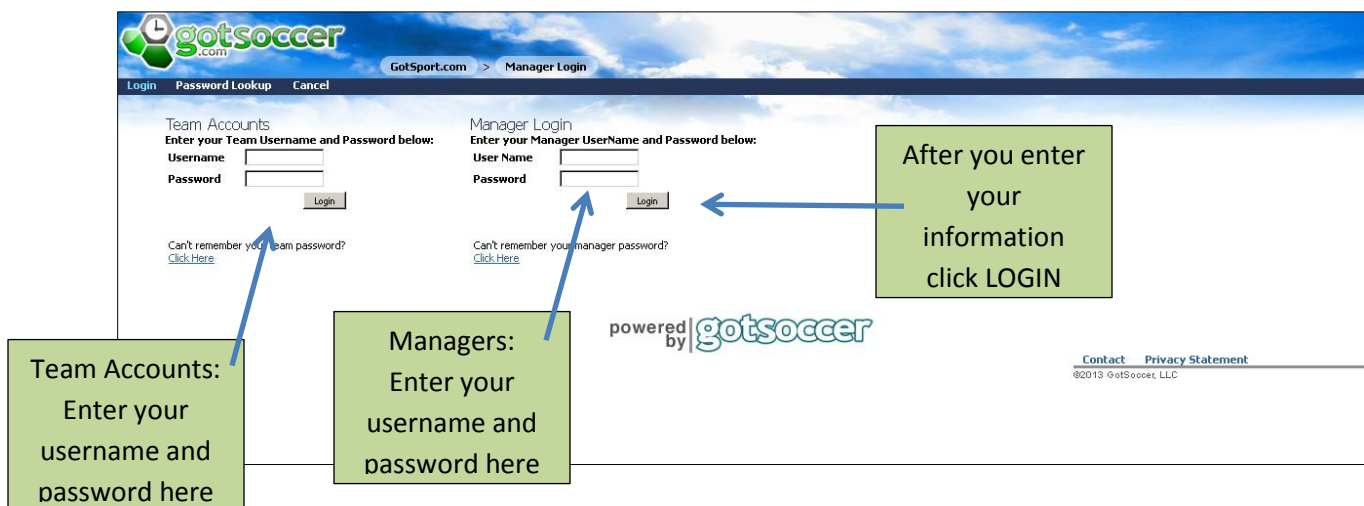


How to complete your MSA Background Check through GOTSOCCER
