

Letter of Application: Orangeville Bengals JR team



Hello Secretary Anderson,

I'm contacting you today on behalf of the Orangeville Bengals JR baseball team. As the head coach of the newly formed team, we'd like to apply to participate in the 2018 North Dufferin Baseball League JR. season. In the following paragraphs, I will demonstrate to you, as well as the league stakeholders, why we'd be an exceptional addition to the league.

The reason why our team would like to join the NDBL can be traced back to the end of last season. Most of our committed players, as well as myself as an assistant coach, were all part of the Bolton Braves Baseball Association's midget rep team. After a third-place finish in the B OBA's ended our season, coaches, parents, and players started talking about how to keep the team together for seasons to come. Many players on this team had been playing in Bolton for the past 3-4 seasons, so when the head coach decided to respectfully move on from the team in September, my father and I decided to organize a JR team.

We first tried to organize the team in Bolton but unfortunately diamond time is virtually unavailable at their facilities. As such, we decided to look to neighbouring organizations to see if they could host us. Our first option was Orangeville, especially considering over a third of our players came from Dufferin county. I reached out to Dave Parsons, President of the Orangeville Minor Baseball Association, in late 2017. He responded positively shortly thereafter, and we got to work organizing a team.

Since we started organizing in November, 11 players have committed themselves to the team: 10 players played last season the 2017 Bolton Braves midget team; and 1 player coming from the Alliston Athletics SR. team. We intend on holding

tryouts at the end of April to complete our roster. Additionally, we've worked OMBA so

that we play our home games at 1:00pm Saturdays at Springbrook Park. We might

need to work around a few conflicts with house league and the Sr team, but as a

backup we can also schedule games at either 3:00pm Saturday or possibly Friday night

at Princess of Wales.

As far as finances go, you and I have been in brief communication regarding all

NDBL fees. Based on our conversations (as well as some digging on the NDBL

website) we've taken the following NDBL expenses into account:

League Fees - \$250.00

Awards Contribution - \$50.00

Statistician - \$50.00

Security Bond - \$100 (To be paid back)

OBA fees - \$100

I'm currently working with the OMBA to determine Registration and Rep fees, but

basically every other fee has been accounted for. I will be bringing an updated copy of

our Budget to the Annual General Meeting on Sunday.

In conclusion, The Orangeville Bengals JR team would make a fantastic addition

to the NDBL's 2018 campaign. This is a close-knit group of players coached by a

Father-Son duo, and we intend on competing strongly and respectfully. If you have any
